A Man Gored to Death in a Mexican Bull

May Not Go to Prison.

A New York paper prints the following from Albany: John Y. McKane is safe and unless something unforeseen happens he is saved from a felon's cell for many months to come, and perhaps he will never be required to wear a prison suit. Judge Edmund F. Tracy, consented to issue a certificate of reasonable doubt, provided such certificate was not issued by Judge Cullen of Brooklyn. Judge Cullen has not as yet heard any argument upon the motion now before him and will not in any likelihood be in position to give his decision for a week. For the moment, however, the action of Judge Tracy is jealously guarded by the McKanes at Albany. The plea made before Judge Tracy is that the McKane jury was tampered with while out of the jury box and that the jury rendered a verdict upon public sentiment rather than upon the testimony presented.

Cool Robbery of a Jewelry Store.
At Hancock, Mo., a stranger entered the store of W. H. Allen, Son, and with a revolver in his hand ordered "hands up." Mr. Allen and five or six men were in the store, and the order was promptly obeyed. He then proceeded to the money drawer, taking its contents, helped himself to some jewelry, a revolver and all the cartridges in stock, coolly bade the occupants good bye, backed out of the store and escaped before realizing the true situation. One of the robbers in the store attempted to leave the building under flight when the robber commanded him to return, which he promptly did with his hands elevated.

Buffalo Costello Ships Again.

"Buffalo" Costello has returned to exile in Canada, after secretly coming back to Chicago. He remained in hiding until Saturday night, and when surrounded by detectives on the west side, alighted from a how now to say Chicago papers. He had forfeited his \$4,000 bail to appear before an Indiana court in connection with the Roby fire fight case and the Indiana Supreme Court will not have a chance to test the McHugh law, legalizing glove contests, by passing on Costello's case. This means that the Roby, or Columbian Club will have no chance to bid for the Corbett-Jackson mill.

Trade Robbers Executed.

Joe Hardin, the Centralia train robber, who escaped from the Chester, Ill., Penitentiary recently, where he was serving a twenty-years' sentence, was captured three miles from Menard, Ill. He was in hiding with friends, but was overhauled by Warden J. D. Baker. Hardin escaped from prison by secreting himself in a wagon load of dirt that was hauled out of the prison yard and dumped into the river.

Tramp's Horrible Crime.

Mrs. Freda Rothschild, wife of a live stock dealer, was assaulted at her home in Omaha, by a tramp, who attempted to outrage her. She beat him off, and finally the tramp, for revenge, thrust her into a closet, set fire to her clothes, robbed the house of jewelry and decamped. Mrs. Rothschild is so badly burned she will probably die. She is a sister of Andrew Bass, a wealthy ranchman.

Millett in the Arms.

The bull fighting festivities at Morelia, Mexico, were attended with another gory and tragic scene. One of the bulls made a quick and valiant attack on Jose Barrera, the matador, and before he could evade the enraged animal he was thrown to the ground and gored to death. The banderilles and other performers had a very exciting time killing the mad bull.

Robbers Sentenced.

Pittsburg special: The Mansfield coal miners were sentenced by Judge Ewing, the other day, to the thirty-five foreigners convicted, seven were sentenced to the penitentiary for terms ranging from fifteen months to two years and six months, and twenty-eight were sent to the work house for terms running from two months to one year.

Teek His Roll.

Jacob Heaston, a well-known citizen of Warren, Ind., was awakened the other morning by three masked men who robbed him of \$1,500 in cash which he had under his pillow. Heaston was a stock buyer and drew the money intending to purchase a car load of horses at Marion. There is no clue to the robbers.

Growth's Malady.

Official returns from all but nine of the sixty-seven counties of Pennsylvania show Graw's plurality up to the unprecedented figure of 180,133 a gain of over 47,000 over the plurality given the Republican candidate for State Treasurer. It is now estimated that Graw's plurality will be 185,000.

Fires at Fort Wayne.

The store buildings occupied by Voddenmark & Sons, Thing & Co., Wm. Meyer & Bro., and Mergenthaler's Bazar, at Fort Wayne, Ind., were completely gutted by fire. Loss \$350,000.

A New Ship Canal.

Ottawa (Ont.) special: Col. Tisdale, M. P., for South Norfolk, has deposited with the Clerk of the Railway Committee of the House of Commons the draft of a bill to construct a ship canal in the St. Clair and Lake Erie Ship Canal Company, which has for its object the construction of a canal thirteen miles long from Lake St. Clair to Lake Erie. The canal will save a great detour to vessels which at present have to utilize the Detroit River. The capital of the proposed company is \$5,000,000.

The woman suffrage convention, in session at the National Capital, elected the following officers: Susan B. Anthony, President; Dr. Anna B. H. Chapman, Vice President at large; Rachel Foster Avery, of Philadelphia. Corresponding Secretary: Mrs. Harriet Taylor Upton, of Ohio; Treasurer, and Mrs. Ellen B. Dierck, of Boston, and Josephine K. Henry, of Kentucky, Auditors.

Fortune in Tin Mine.

Chicago miners had a fierce battle Monday night with a blaze that broke out in Norton Brothers' can manufacturing establishment. The building, a six-story structure, was destroyed, with its valuable machinery and contents. It is estimated that the loss will be \$200,000.

Telegraphic reports from many points in Colorado and New Mexico disprove the reports that range stock is dying by thousands on account of the severe weather. It is hardly possible stock will ever again suffer as it did in the winter of 1886.

Thirty-nine Perch.


Edward White will take his seat on the Supreme bench as the youngest of the justices, and, with the exception of Justices Field and Harlan, he will enter at an earlier period in life than any of the other justices, and will have the exceptionally long term of twenty-one years to serve before retirement. He was born in the parish of La Fourche, La., and was 48 years of age last November. He was educated at the University of New Haven, Emmitsburg, Md., at the Jesuit College in New Orleans, and finally at Georgetown College. He entered the Confederate army, and after the war was admitted to the bar by the Louisiana Supreme Court, and practiced his profession during the troubled years following the reconstruction period. In 1874 he began his political experience as a State Senator, and in 1876 he was elected Associate Justice of the Supreme Court of Louisiana in 1878, but again turning to political pursuits he was elected to the United States Senate to succeed Senator Finsen, at present Ambassador to France, taking his seat March 4, 1891. By his appointment he will leave a vacancy for full two years in his Senatorial term.

STOCK YARD SCANDAL.

Lame-Jerked Cattle Slaughtered and Sold for Food in Chicago.

Chicago is eating diseased beef. It is not a pleasant statement to make or pleasant thing for Chicagoans to contemplate, but it is the truth, at least so say the Chicago papers.

Briefly told, there is not a shadow of a question but that from 100 to 150 diseased animals are spirited out of the yards each day, and are sent to market in the refrigerated trade.
