DOINGS OF THE DAY.

SUMMARY OF THE NEWS OF THE WEEK.

Strikers at Chicago Pay Little Attention to Troops and Jostle and Jeer the Soldiers—Many Buildings at the World's Fair Destroyed by Fire—Aerial Accident.

TURBULENT

At the Situation at Chicago in the Strike District.

Chicago special: The sun went down Friday, on by far the most turbulent and critical day thus far in the unparalleled railroad strike and boycott. When it opened there was a general feeling that its passage would go far toward ending the atmosphere of alarm it did not produce, yet it has embargo on commerce for the past week. The situation at the close of the day did not realize the hope indulged at the opening. The troops, few in numbers, were divided into squads and distributed at points separated by considerable distances, and so far as ever the situation has been neutralized. Instead of fleeing before the troops, turbulent thousands surged about the little band of soldiers, jeered and hooted, cast vile epithets, literally played hide and seek with them, stopping trains at will, and generally rendering the atmosphere in the military camp more effervescent than before. The throngs of strikers did not resist Uncle Sam's police. Again and again, when they were thousands upon thousands of them above the train, which it was sought to move, and on the tracks in front of it, they gave way like water before the leveled bayonets of a single company of cavalry or the roar of a single squad of artillery. Like water, too, they closed in again at a point just beyond. They turned switches, derailed freight cars in front of the slow moving trains, and played all sorts of railroaders' tricks, with which the soldiers were unacquainted. Thus it was that the troops at the stock yards spent the entire day in a vain endeavor to get one train load of dressed beef out of sight of the starting point.

Gen. Miles has received a dispatch from Gen. Schofield at Washington telling him to order more troops from Fort Leavenworth, Kan., and Fort Wayne, Mich. These will swell Gen. Miles' force to the full regiments of infantry, beside the battery and cavalry. Debs has issued an address to the people reviewing the Pullman strike, charging that the railway managers are siding with Pullman. He says that arbitration by Pullman and restoration of the employees by the railroads will settle all.

The White City in Flames.

Chicago special: What is left of the gilded statue of Columbia, near the eastern end of the court of honor, the central point of interest for thousands of visitors, was reduced to a smoking cinder, looks out upon a waste of ruins and ashes. The six large structures which formed the boundaries of the court of honor were burned by incendiaries early Friday evening. The buildings destroyed were the terminal station, administration, electrical and mining buildings, Machinery Hall and the Agricultural building. The art gallery, which has been rechristened the Field Columbian Museum, and the Government building were saved, together with the minor buildings, south of Machinery Hall and the Agricultural building. The art gallery started almost simultaneously at three points, so selected as to afford the best possible opportunity for the spread of the flames.

Aerial Accident.

A terrible accident ended the race at Riverview Park Joliet, Ill., and cost a life. "Prof." Jones, of Bloomington, was to make a balloon ascension and parachute fall. The weather was an ideal one for two. The wind was blowing strong and the ropes broke. Jones had to let the balloon, which went up, dragging him through a tree and tearing his clothes off. At a height of forty feet he was forced to let go and fell to the ground, breaking both arms and one leg. The bones projected in every direction. A doctor in the grand stand pronounced Jones injured internally. Blood was running from his nose and mouth.

Carsman Drowned.

St. Louis special: The six-carred racing boat of the St. Louis Rowing Club, while out for a spin, struck a concealed log in the river just above the Eads bridge and upset. Fritz Sosner was drowned. The remainder of the crew clung to the boat or swam out.

The Pope's Last Wishes.

The cardinal of the London Times at Romsey says the Pope's health seems to be failing. He has delivered a sealed packet, supposed to contain his last wishes, to a Cardinal with instructions that it shall be opened after his death.

Killed His Children and Himself.

Butler (S. D.) special: K. B. Ovam, a Norwegian farmer, became so tired over crop prospects that he cut the throats of his two children, aged six and eight, threw them in a well, cut his throat and jumped in after them.

Air-Line Brakeman Killed.

John Boyer, a brakeman, was run over and killed by an air-line passenger train at Rockport, Ind.

An Old Farmer Kills Himself.

John Dunlap, aged 60, prominent farmer at Berlin, Ohio, shot himself dead. Dunlap had engaged in litigation and this with domestic troubles preyed on his mind.

Victims of a Gasoline Explosion.

At Louisville, Ky., by the explosion of gasoline. Henry Zimmerman was fatally hurt, his wife lost her life and their 9-year-old boy was badly burned about the head.

Swept by a Windstorm.

A windstorm of unusual severity swept over Eastern Arkansas and the western portion of Tennessee Sunday night. Telegraph, telephone and telegraph wires were broken in Memphis and several trains were seriously crippled. Subsidiary lines broken from their moorings on the river and derailed helplessly before the wind. Five barges of coal were sunk near Jackson, Tenn.

Guilty of Murder in the First Degree.

At Jackson, Mo., the jury in the Newman case was out two hours and brought in a verdict of murder in the first degree. The court overruled the motion for a new trial and sentenced the prisoner to be hanged on Friday, July 27. The attorneys for the defense asked for an appeal, which was denied.

END NOT IN SIGHT.

Pullman Boycott Results in an Intersub-
stantial Tangle of Railways.

The fight between the American Railway Union and the railroads on Saturday had grown fiercer than ever. The road officials had repeatedly declared that the boycotters were losing strength, and at each such declaration President Debs, of the A. R. U., came to the rescue. He urged the union to invoke some other road. The original object to compel the Pullman Company to arbitrate its differences with the original Pullman strikers, seemed to have been lost sight of altogether, and the contest became a trial of strength between the two and their allies. He urged the union to invoke the Knights of Labor as an ally. Many other labor organizations stand ready to join the boycotters, while still others maintain a neutral attitude. Saturday morning was not an employee of the Chicago Stock Yards Transit Company reported for work. This is the heaviest load yet thrown on the railroads. Colored Assassin Strung Up to a Telegraph Pole by a Mob.

Sulphur Springs, Tex., has been in a high state of excitement over the foul assassination of Mrs. Al Waits and the shooting of her son, William, by John W. Waits, who was once the boy's employer.

The dastardly deed was committed about 9 o'clock Thursday night. While Mr. and Mrs. Waits were in the corn porch the negro stole into the house, procured a shotgun and laid it in wait for and shot them. Most of the charge took off the back of Mrs. Waits, hitting her instead, while her husband was also seriously wounded that he will not recover.

The couple had only been married a short time. After committing the crime the negro fled, but was captured and conveyed back Sulphur Springs, where an immense mob secured the negro and hung him from a nearby telephone pole. Several hundred shots were fired into the swinging body.

Prominent Officials of the Penn Steel Casting Works Arrested.

When Visited by the Police.

The police visited the lodgings of a man named Granier in Montpelier, France, to ascertain his connection with the murderer of President Carnot. It is alleged that about 4 o'clock Sunday afternoon Granier was heard to say: "By this time Carnot must have received his account." When the police arrived at Granier's lodgings they ordered him to surrender. With a quick movement Granier took off his coat and seized a large knife which was lying upon the floor and plunged it into his abdomen, falling dead at the feet of the police. The police are now certain that the murder of President Carnot was the result of a conspiracy between Santo, Labore, Granier and others to avenge the executions of Vaillant and Henr.

ROBBERY RESORT TO TORTURE.

Hold a Storkeper's Feet in Flames Till He Surrenders His Money.

Three men broke into the general store owned by John Howard, two miles from Parker, Pa. Howard was asleep and they bound and gagged him and made a thorough search of the premises. Finding no money they took him to a room above the store and there beat him until he was unconscious. They then held his bare feet over the flames of a lamp until he weakened under the torture and told where \$170 was. They took this and a quantity of goods and left Howard in a critical condition.
