The report of the state mine inspector, Robert Fisher, which appears in connection with the geologist's report, shows that 5,177,044 tons of coal were mined in Indiana in 1898, which was an increase of 548,988 tons over the output of 1897 and was 628,283 tons more than had been mined in the state in any previous year. It is said in the report that the increase was due to the absence of the usual strikes of miners in the principal coal districts of the state and to largely increased demand for Indiana coal during the last three months of the year. This demand, it is said, was brought about partly by the shortage of the supply of natural gas. "There is no doubt," the inspector says, "but that the demand for Indiana coal will gradually increase as the supply of gas grows less and the chances are the output will reach 10,000,000 tons per annum before the year 1910." In 1898, 9,325 miners were employed in the state.
