This Date in History—Dec. 2.

157—Hernando Cortes, conqueror of Mexico, died near Seville, Spain, born 1485; March 4, 1549, he first landed in Mexico and took the capital city Aug. 13, 1521.

158—St. Francis Xavier, apostle to the Indies, died near Macao, China, born 1506; he preached in 52 nations and baptized over 1,000,000 persons.

159—Richard Montgomery, soldier, born in New York, French killed in the 1801 battle of Austerlitz and great victory of Napoleon. The Austrians and Russians lost 30,000 men. This battle caused the death of William Pitt.

160—Pedro, the second and last emperor of Brazil, born 1808.

1848—Francis Joseph was declared emperor of Austria.

1851—Comp't d'etat in Paris, overthrow of the public and beginning of second empire.

1859—John Brown, hanged at Charleston, Va., now a national hero.

1869—Albert Barnes, Bushardson, journalist, died of wounds inflicted by Daniel Macfarlane; born 1833.

STATE NEWS.

Interesting Telegrams from Various Indiana Towns.

Gave Illinois Twenty-one Years.

INDIANAPOLIS, Ind., Dec. 2.—Charles Bissell, the object of the lynching-bash fiasco of Monday night, was on Tuesday sentenced to twenty-one years in the state prison for a criminal assault upon Blanche Staton, aged 9 years. After the experience with the mob, Sheriff Langenberg took the first opportunity to confer with Judge Cox and the prosecuting attorney. It was decided to run no further risk and to bring the prisoner into court upon an affidavit and information. He answered "guilty" when asked to respond in his usual brazen tone. Judge Cox then explained the law to him, and stated that its maximum limit is twenty-one years, but that is not any too severe. He would therefore give him the full extent of the law. The prisoner was handcuffed and taken directly to a neighboring livery stable, where he and his guards entered a carriage and drove to a rural railway station en route to the penitentiary. Judge Cox in his remarks referred to the mob as an "unlawful assembly," and it is expected that the grand jury will investigate the case.

Will Recognize Neither Fund.

INDIANAPOLIS, Ind., Dec. 2.—The trustees of the state soldiers' orphans' home at Knightstown met recently. In the regular appropriation bill the legislature gave \$95,000 as a fund to maintain the home, but in a subsequent special law an appropriation of \$15 per month per capita was made. The minds of the trustees are confused as to how they shall be guided in spending either appropriation, and the state auditor will recognize neither fund until the matter is legally settled. The trustees say that the appropriation of \$95,000 is not enough to maintain the home, which now has nearly 700 inmates and officers, but that with \$15 per capita it can be done. The report shows that the school is a success. Only two deaths occurred in it during the year.

Death of Isaac M. Brown.

COLUMBUS, Ind., Dec. 2.—Isaac M. Brown, the founder of many newspapers and the oldest editor in Indiana, died Tuesday morning aged nearly 75. He had always confined his labors to Indiana, having published papers at Bloomington, Sullivan, Terre Haute and this city. He was postmaster at Sullivan in 1873 and editor and publisher of the *Sullivan Union*. In 1892 he, while engaged in the printing business at Terre Haute, packed his printing material, stowed it in the cellar and, with his employees, joined the Sixth Indiana cavalry and was in thirteen of the hardest fought battles of the rebellion.

Destroyed by Fire.

INDIANAPOLIS, Ind., Dec. 2.—J. Fisher's livery stable, with six horses, vehicles and feed, was destroyed by fire recently. Loss, \$2,000; insurance, \$1,500.

The building destroyed was always regarded with superstitious dread, owing to a brutal murder committed in one of the upper apartments in 1879. A man named Merrick murdered his wife, placed her body in a buggy, at midnight took her out and buried her on the banks of Eagle Creek. Merrick went to the scaffold prepared until his nose pressed his breast, and is too busily engaged to notice the snuffing sound that is becoming alarmingly frequent.

Had Their Cases Continued.

WASHINGTON, Ind., Dec. 2.—The trial of ex-Auditor James C. Lavelle and Aaron B. Hawes of Daviess county, charged with arson, was set for Monday in the Pike county circuit court at Petersburg, 12 miles south of this city. The prominence of the accused had created more than local interest, especially when coupled with the strong circumstantial evidence of their guilt. The defendants appeared in court and through their attorneys asked that the cases be continued until March. Their request was granted.

Fourth-Class Postmasters.

INDIANAPOLIS, Ind., Dec. 2.—A meeting of the fourth-class postmasters was held here to consider proposed legislation in their behalf. They wish an allowance for light, fuel and rent, and an increase of compensation. In the discussion of these matters preference was expressed for a yearly salary instead of commissions on canceled stamps. Five delegates to the national convention of fourth-class postmasters in Washington were chosen.

Launched a Fine Boat.

JEFFERSONVILLE, Ind., Dec. 2.—The finest steel hull ever launched in the west went into the river at Sweeney's Monday. It is an express steamer for Capt. William Bay, to run between Ironton and Huntington, O., 20 miles. The boat is to make the distance in an hour or less. She is 120 feet long, 18 feet beam, built on lines of the celebrated Cushing, with twin screws of 225 revolutions per minute.

Choked to Death.

HANNA, Ind., Dec. 2.—The 7-year-old son of Charles Berridge was choked to death Tuesday by a picket nut becoming lodged in his throat.

A couple named Block was arrested at Bay City, Mich., for passing counterfeit \$20 gold certificates.
