A 32-caliber Smith & Wesson revolver with three empty chambers, a bottle of chloroform and a razor were found on him. Lyons was brought before Chief Dietrich and he stated that he made his home in Chicago. He acknowledged having passed through Seymour, Ind., about the time of the murder. He denied any knowledge of the murder and expressed himself as perfectly willing to return to Seymour. Telegrams from Seymour confirm the belief that Lyons is the right man. These telegrams state that there are five negroes under arrest at Seymour, but that the one who is wanted now is a white man from Chicago. This is but 20 miles from Indianapolis and is the route taken by Lyons while coming to this city.
