THURSDAY, March 11.

**FLOUR**—The demand was quite limited today, being confined to the wants of the local dealers, and prices tended downward. The sales were confined to about 1,200 bbls. at 3,700<sup>75</sup> for superfine, and 3,800<sup>30</sup> for extra; 2,364 bbls. were received during the last 24 hours.

**WHISKY**—The market is steady, with sales of 960 bbls. at 16<sup>12</sup>, and 290 from wagons at 16<sup>12</sup>.

**PROVISIONS**—The market continues firm, without any activity. Mess Pork is held at 15<sup>25</sup>, but without finding buyers. Lard is held at 9<sup>12</sup>, but no buyers at over 9<sup>12</sup>.

**GROCERIES**—Sugar and Molasses are held with more firmness under the advices from New Orleans. Sales of 100 bbls. Sugar at 75<sup>75</sup>. Molasses is held at 35c, but small orders are being filled at 33c. The price is unchanged.

**WHEAT**—Prime White is in good demand and sells readily at 90c. The lower grades are dull at 70<sup>80</sup> to fair for good White, and 65<sup>70</sup> for Red. A sale of 700 bush bush White at 90c.

**CORN**—The market is firm with a good demand. Sales 800 bush at 35c.
