

THE AMERICAN TREATY WITH CHINA.

Among other stipulations of the treaty between China and the United States are the following:

A direct correspondence between the American Minister and the government at Pekin. The right of an annual visit to Pekin, and permanent residence of the Minister there, with not more than twenty in his suite, it accorded to other powers. The suppression of piracy, and the opening of new ports, to include Swatow and Taimen, in Formosa. The United States shipping never to pay higher duties than those of the most favored nations. The double tariage duty abolished. Absolute toleration for Christianity. The legation of the United States is to be located for the present at Canton, but hereafter it will be stationed at Shanghai. Exclusive jurisdiction of the United States authorities over the rights and intercourse of its citizens. Immunity of national flag and obligation of neutrality. Apprehension of mutineers and deserters, and of punishment of criminals. All other rights and powers granted to any other nation, not mentioned in this treaty, to insure the benefit of the United States, its merchants or citizens. The treaty to be ratified within a year by the United States, and by the emperor forthwith. The claims for pecuniary indemnity, either for English, American or French losses neither admitted nor denied, but referred to Canton.

HOW TO DEVELOP MAN PHYSICALLY.—The editor of the New York *Clipper* has been visiting Morrissey, and in his paper of this week gives the following account of the training process under which it is hoped to bring the muscles of the prize fighter to the most perfect development. As the system of training which he is now pursuing differs considerably from that which we have previously described, we give a brief abstract of it. He rises at 5 o'clock in the morning, and undergoes a cold bath, having a couple of pails of spring water poured over him, and well sponged with it. He is then rubbed dry with coarse towels, and after dressing starts off on a three mile walk, running an additional half mile. Every other morning before thus setting off, he drinks a large glass of the finest sherry, with an egg beaten up in it. On his return from that appetite creating excursion, he uses the skipping rope for twenty minutes, to exercise and strengthen the muscles of the leg, and finishes with the dumb bells for a quarter of an hour. Eight o'clock has by this time arrived, and he goes to breakfast with an appetite by no means lessened by his morning's exercise. At meal he partakes of a cup of tea and a broiled mutton chop. After breakfast he walks 44 miles out to a house, where he takes a glass of Murphy's fine old ale, and a crust of home baked bread.

Returning, he runs a mile at the top of his speed, and on reaching his hotel is well rubbed down by his trainers. He then, after changing his dress, commences with the weight machine, and finishes the morning's work with "fighting the bag." During hour, one o'clock, has now arrived, and here a large cut of sirloin or beef, or of mutton awaits him, varied occasionally with a broiled chicken. He is allowed but little water, and after dinner he takes half a tumbler of sherry, with a piece of dry toast. He then washes his face and hands in a liquid prepared by his trainer, the object of which is to harden the flesh on those parts. He now starts off on the afternoon's walk of eight or nine miles, returns, uses the bag for twenty minutes, and is well rubbed down. He diversifies this routine by sparring with Shepherd, Lawrence or Burns, and using the weight machine. Tea at six o'clock, comprising a light broiled egg and mutton chop, or broiled chicken, and a single cup of tea. Afterwards he takes a rest for half an hour, and then amuses himself with rowing on the river for an hour or so. After again washing his hands and face in the liquid before mentioned, he imbibes half a glass of sherry wine, and eats a crust of stale bread, before retiring for the evening, which he does at eight o'clock, again to rise in the morning and pursue the same course of exercise or dietetics.
