MONDAY.

The only business of importance before the Senate was the President's veto of the bill to make the blacks of the District of Columbia voters, and disfranchising those who took part in the late war in behalf of the Southern Confederacy. The bill was passed over the veto by a vote of 29 to 10 days.

The House devoted its time mostly to the President. Mr. Loan, of Missouri, introduced a resolution to impeach the President. The resolution created considerable excitement, but under the decision of the Speaker it was sent to the Reconstruction Committee, as it also contained a provision to reconstruct the Southern states. Mr. Kelso, of Missouri, then introduced the impeachment part of Mr. Loan's resolution, which was laid aside, on account of the hour having expired for the consideration of resolutions. Mr. Ashley, of Ohio, on a question of privilege, introduced a preamble and accompanying resolution, charging high crimes and misdemeanors on the President, and directing the Committee on the Judiciary to take testimony to ascertain if the House should not take action in the premises by impeaching that high public functionary. Much excitement followed the introduction of this preamble and accompanying resolution. It was very plain that the Speaker and other leaders had had a previous consultation on the subject. The preamble and resolution were adopted and sent to the Committee by a vote of 106 to 27 to 25 days.

This unexpected vote, giving such strong backing to the ultra Radicals, is regarded as conclusive that it is the intention of the Revolutionist to depose the President. The Senate, suspending payment to loyal owners of colored volunteers, was passed—yeas 106, nays 27.

TUESDAY.
