but not McClure. They came at 2:20 o'clock and stayed half an hour. McClure sat in a chair all the time and created no disturbance.

Lives between Spring and North streets on Walnut next to Coombs. Was there on the morning of the murder. Heard someone slam her gate and asked Sam Coombs to get up, but he was afraid.

It is 90 feet from Coombs' gate to the Sugar tree. Examined the tree limbs for bullet marks and found what looked like one three inches in diameter twelve feet from the ground.

WEDNESDAY. WILLIAM HOLEMAN. Bartender of the Clipper saloon, was the witness called first. Met Randall, Ensminger and McClure in front of Music Hall a little after midnight.

CHARLEY COOMBS. The defendant, was called and took the stand looking more cheerful than heretofore. Went to bed about 9 o'clock that night. Was awakened about 3 o'clock by his wife, who said some one had knocked on the door.

Another Grain Thief. Samuel W. Boots, Jr., of Sugar Creek township, was brought to this city last Tuesday and lodged in jail, charged with stealing \$15 worth of corn from his father, Samuel Boots, sr., one of the substantial farmers of that township.

Voting Places. At the council meeting Monday night the following voting places for the different precincts of the city were selected:

"We, the jury, find the defendant, Charles Coombs, guilty of manslaughter and fix his punishment at 21 years in the State's prison. H. H. TALBOTT, Foreman.

On hearing the verdict Coombs burst into tears and continued crying until he was returned to his prison cell. When the jury retired on Wednesday night, they organized by selecting H. H. Talbott foreman, and at once began balloting.

Nearly fifty ballots were taken and it was not until 8 o'clock Thursday morning that they reached a verdict.

It was simply a compromise verdict. Coombs' attorneys were given sixty days in which to file their motion for a new trial.

A REVIEW man accosted D. F. McClure as to his opinion of the verdict. Mr. McClure said: "I am very well pleased. I expected more, but it is almost as much as a life sentence."

Tried to Kill His Family. Residents in the neighborhood of the Masonic cemetery were startled Tuesday afternoon by hearing screams in the house of Elihu Nicholson, the sexton of the cemetery, and a little later by seeing the wife and children run rapidly from the building.
