## ANTI CATHOLICISM AT LAFAYETTE.

Some two weeks ago a former Catholic priest undertook to deliver at Lafayette a lecture, entitled, "Why I Left the Romish Church," at the Opera House. There were fully 1,200 people present, but in about a half hour after he had begun, a mob of persons, broke in on the stage, knocked him down, and in consequence the lecture was closed at once and the audience vent flying from the house. The members of the mob, it is stated, were Catholics. The lecture was to be delivered under auspices of the "American Protective Association," which made a poor out at protecting the lecturer in this instance. The society is probably anti-Catholic and since this affair, has increased its membership by hundreds, and proposes to secure the ex-priest again to talk to them. It is unfortunate both for the city of Lafayette and the Catholics of that city that such an event was permitted to occur. It is calculated to intensify the feeling already existing among many all over the country that the Catholics are determined, if possible, to overthrow many of the present forms of government, particularly that system relating to our schools. A crisis is predicted by many in this country between the two forces, Catholic and Protestant and war, war to the knife, to follow. This is a country of free speech and free press, and must always remain as such while our present form of government exists. The attempt to suppress the lecturer was wrong, and was not, we believe, approved by the better element of the Catholic church in that city. Had he been permitted to have finished his lecture, what he said would not have raised one-tenth the feeling that the interruption of him has.

## MR. HORD OF MARION.

Marion county has an ideal legislator in a Mr. Hord. He dares to think and act as he believes to be right regardless of cliques, lobbies, or party organization, and no intimidation will work upon him. It pays to be honest and outspoken in political matters although it does not always lead to success. Policy is the line upon which the average politician works, and generally he is under some man or some ring of party managers. "Organized labor" as it is termed, is seeking at this session of the legislature to have certain laws enacted in its favor. Mr. Hord favors it, but likewise demands that unorganized labor should be similarly served. There is just the rock upon which they split—the labor people and Mr. Hord. There is nothing unfair in Mr. Hord's position, yet the labor folks growl, threaten, and do all sorts of mean things toward him on account of it. Most of the other members from fear of the power of the opposition to them, are against him; not that he is not right, but the fear of future political success if they vote and act with him. Why unorganized labor should not have the same rights and privileges as organized labor before the law, would take a profound philosopher to explain, and it would not be explained then. Mr. Hord may be away off the road to political honors in the future yet it is vastly more satisfactory to act conscientiously and independently in a matter like this above mentioned than to be trucklers and time servers like so many of those around him seem to be—to do right regardless of threats or intimidation. That is the style of politician we most admire, and it is to be regretted that the race of them appears to have nearly run out.

As the session of the State legislature is over half through there is already some talk of an extra session. The governor will voice the sentiment of the people if he refuse to call an extra session. There has been ample time to enact all the laws and pass the necessary appropriations, or will be during the next three weeks. If some of the long winded gillies who do so much talking at every session would lose their power of speech for the next twenty days of the legislature, there will be no necessity for an extra session.

Ultra republican papers were fearful that Harrison, his term expiring in a few weeks, would "exercise his prerogative" in the appointing of a judge to succeed Lamar, deceased. He has, however, He has appointed Judge Jackson, of Tennessee, a democrat and a most excellent man for the position, judging by reports. He has failed to exercise it just the way they desired.

There will probably be no amendment to the law regulating the pay of county officers at this session of the legislature, the opinion seeming to be that there should be no tinkering with the present law. County officers who cannot submit to the present order of things will have to resign.

## ONLY NECESSARY APPROPRIATIONS.

The legislator who opposes all appropriations of the State's money, not absolutely needed, has the correct views and sentiments of the people this year. The state debt of near \$9,000,000, must be paid. It must come from the pockets of the tax payers, from thousands of the inhabitants who can ill afford to part with their means. Consequently the member who votes for this or that scheme that a stall fed lobby may originate, is an enemy of the people, is looked upon with more or less suspicion. A grange organization of Boone county lately passed the following resolution and presented the same to its representatives in the legislature. Considering the humble source from whence this resolution originated, there was some disposition to ridicule it among the members, yet it echoes the views of thousands of tax-payers:

Resolved, That Boone County Pomona Grange, Patrons of Husbandry ask the Hon. Senator Thomas E. Boyd and the Hon. Representative, Samuel S. Davis, of Boone county, and that they are hereby respectfully requested to use their power and influence against the following appropriations: For the G. A. R. National Encampment, at Indianapolis, September, 1893, for World's Fair, for marking burial places of Indiana soldiers in the south, for Purdue University, for normal school, and all similar appropriations.

## OHIOAGO'S SCHEMES.

All sorts of schemes are being constantly originated by sharpers at Chicago to get money out of the outside world before and during the World's Fair. For instance for \$1 they will place your name in a guide so when you go up there you may find where your acquaintances are. Several sharps are aiming to inveigle publishers to pay \$1 per week by which they may become members of a "press association," and be enabled to publish letters from the Fair. The folks that have rooms to rent, also many alleged hotels, are getting in their work by getting the country bunks to make advance payments for rooms. One individual formerly of this city who has sent out thousands of circulars descriptive of his hotel, the prices to be charged, and requesting a check from each person addressed to secure them their rooms in his house, it is said has not even yet laid the foundation for his "hotel," but has secured several thousands of dollars from persons he has addressed as advanced payment for board and rooms. Our advice is not to pay a cent in advance to any of these people, but wait until the Fair opens, go up and risk your chances then of getting what you seek for your money. It will be much more satisfactory to be present if you are to be swindled, than off at a distance.

## THE JOSEPH E. McDONALD WILL CASE.

The suit of Malcolm McDonald and others to set aside the will of the late Hon. Jos. E. McDonald, has been in progress some weeks in the Hamilton county Circuit Court at Noblesville. The charge of the plaintiffs is that the will is forged, is not that of the deceased and intimate that it was done by or through the connivance of his widow, Mrs. Josephine McDonald, his third wife. Many witnesses have been examined, among them John M. Butler, his law partner, Park Daniels, a law student, two experts on signatures from Chicago, and others. Their general testimony and belief is that the name of McDonald as subscribed to the will, is a forgery. The plaintiffs seem to have the best of the case, and the "will" will probably be broken. McDonald left property valued at \$100,000, mostly in Indianapolis real estate.

A negro last week at Paris, Texas, who had raped a four year old girl, was captured next day and suffered the most horrible death that could be devised. He was stripped, placed on a platform, his body pierced all over with hot irons, and coal oil finally thrown over him and then set on fire. His sufferings were indescribable. The act partakes of barbarity and the worst form of heathenism. While rape, we believe, should be made a capital offense and the criminal suffer death, there are certainly more civilized ways in going about it than the Texas mob adopted. The fewer such punishments are heard of the better, especially in any country where they claim to be civilized and enlightened.

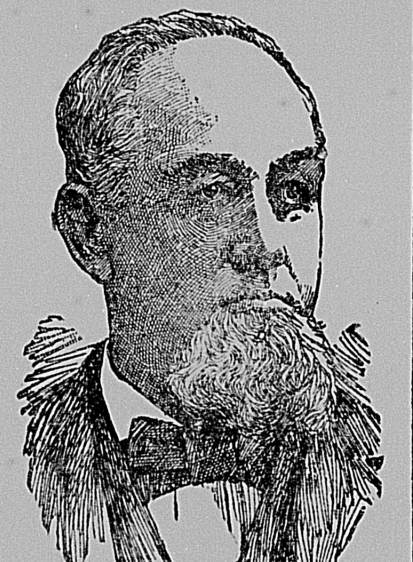
