**AN INDEPENDENT ON THE A. P. A.**  
 The new semi-secret organization, the A. P. A., is beginning to attract some attention among the politicians. It will for a time cut an important figure in the elections, but like anything of a secret political nature will become odious to the people and fall to pieces. The A. P. A. was first organized in this state at Lafayette some months ago, and at this time claims to have in that city alone 2,100 members. Councils of the order have been formed in Indianapolis, South Bend, Elkhart, Muncie, Logansport, Terre Haute, Crawfordsville and many other towns in Indiana. Councils of the order are being organized every week. The aim of the order mostly would seem to oppose and vote against any one for office who is a member of the Catholic church. A politician of this city, an independent in politics, and who in conversation one day last week seemed posted somewhat on political affairs, said to a reporter of this paper:

"Socially or in business matters the American Protective Association has no enmity towards Catholics, but in politics they have and hereafter propose to exercise their power to rebuke them. You cannot go into any town or city of any consequence in the country but what you see Irish Catholics holding office or preparing themselves to run for public places. And they do it by holding a club over the party's head in the shape of 'the Irish vote.' They have intimidated both the old parties long enough and we (the A. P. A.) propose to show them what there is in 'the American vote' hereafter. The opinion is growing among many republicans and democrats that this 'Irish Catholic vote' business has gone far enough, and the way to right matters is to vote against them at every opportunity and teach them that they are human beings, no better than any body else, and entitled to no more than any body else if they do belong to some special church or nation."

"Do you notice," said the individual, "how this feeling is gradually growing here in Montgomery county. Johnston, a Catholic republican, and Carroll, a Catholic democrat, were both gracefully retired last year. The feeling I spoke of in both parties actuated the voters more or less, and is the cause in most respects that defeated them. Look at your own damned cowardly delegates at your convention last year. They threw overboard McKee, a worthy man, a working democrat, and a man well entitled to the place, from fear of the 'Irish Catholic vote,' and placed Wren, an Irish Catholic on the ticket. McKee would have been elected by 100 majority, but your cowardly political managers had him defeated at the nomination and Wren at the election. That was one time when policy failed to triumph over principle. We propose that these fellows shall take a back seat now. I have a most contemptible opinion of any class which considers its allegiance is due first to the pope and the country afterwards and that is just the way these fellows view it, and if they are sincere they will tell you so."

**P. O. GROWLINGS.**  
 There has been considerable growing and some expressions of anger at the appointments of some persons to several of the smaller postoffices of the county, no more perhaps than is usual, however, when a new man assumes the control. The dissatisfaction is often the loudest from those who were applicants themselves and failed to secure what they were seeking. Many of them seem to overlook the fact that they themselves would no doubt be subject to the same criticism and the same objections that they so freely bestow on the new appointees. Take the ten applicants for the Crawfordsville office for instance. Nine of them will remain in the ranks of private citizens, and will, no doubt, freely use their tongues in describing the unfitness of the other man who was more lucky than they. It is easy to criticize the short-comings of others, but grating to the ear to have one's self maligned. In the case of the smaller offices it rarely pays any man of business to be encumbered with a post office, although a responsible representative citizen is and should be sought, and the appointing of a deputy of opposite politics would to most people seem a decidedly small matter. His influence generally cuts as small a figure politically as does his post office. Democratic deputies for republican post masters were quite common during Harrison's administration in thousands of the smaller post offices of the country. There is little need of making "kicks" over this or that appointment. It does no good. If the appointment is a poor one it is not your fault.

**CARLISLE VS. WALL STREET.**  
 Wallstreet, New York, tradition says, controls the money business of the United States, and regulates the financial interests of this country. In the haste to secure gold for shipment last week to Europe, what was known as the "Gold Reserve," which is a sum of \$100,000 in gold held continually by the government, was drawn upon by Carlisle, Secretary of the Treasury, for the emergency and the demand promptly met. This was something new to Wall street. The republican secretaries of former administrations had always heretofore consulted Wall street in any financial movement to see if it was satisfactory to it. That money center has little sentiment and less patriotism. Its money monarchs care little for the government only so far as it may contribute to their accumulation of wealth. In the late financial flurry Wall street expected the government would promptly issue interest-bearing bonds by which it might make some profit, but the government did not, and this was what surprised Wall street. It is quite probable that the government could continue to exist and prosper if Wall street were swept into the ocean. The independence shown by Carlisle is commendable. The government should be independent of all interests except the protection of its citizens. The money power should be entitled to the respect only that it demands. There has heretofore been too much abeyance to it. It should show some spirit of patriotism and liberality toward the power that permits it to live. A determined, earnest and patriotic course on the part of the Secretary of the Treasury in all emergencies like that of last week, will meet the approval of citizens whether it does that of the shysters of Wall street or not.

**THE ORPHANS' HOME.**  
 For some weeks past the Commissioners have had under consideration the location of a new Orphan's Home. It is remarkable the number of persons having property to sell that would, in their opinion, be just the location for the Home, and the free advice given the board on the subject is fully as marvelous. It is said that no less than sixteen persons have property to sell to the county that would be the exact proper location needed. The Myers homestead with five acres of ground on west Market street can be secured, also Britton's Glenn of 20 acres just west of the corporation on the Yountsville road, the Keeney property, consisting of a large frame house and four acres of ground, south of the city, are all for sale to the county if terms can be agreed upon, also several other places. The aim should be healthiness of location, water and convenience to school. Why a new home, erected on the south part of the farm owned by the county, northeast of town, would not answer fully as well as any other location, cannot be explained. It would be but a short distance from the Fiskville school, water could be easily supplied by the water works company, and the location is high, dry, and healthy. The sale of the 16 acres on the Yountsville pike would go far toward paying for the erection of a new home.

**TESTING THE LAW.**  
 Sheriff James W. Stout, of Vigo county, began suit in the circuit court last week against Auditor of State Henderson, for a mandate compelling the latter to pay allowances claimed to be due for transporting prisoners from Terre Haute to the prison south. It is intended as a test of the constitutionality of the present fee and salary law, and it is understood that a large number of the Sheriffs of the State join him in this suit, or at least pro rate with him in all costs that may accrue in the matter. If the present law regulating county officers' salaries is declared constitutional and remains in force one good thing at least will arise from it. It will to a great extent do away with the scores of men in every county in Indiana that are continually shaping themselves to run for office, whose minds are constantly engaged in evolving schemes to be elected to official position. It will have the effect with many of them to seek some other means of earning a livelihood. Few men want office for glory alone; most of them prefer the cash that it brings with it. Now if there is nothing in the office but a "living," hereafter there will be many less applicants, and men will get down to solid work instead of wasting half their lives in seeking positions. In this respect at least, if in nothing else, the present law is very satisfactory.

**YOUNG WM. ENGLISH,** of Indianapolis, who sought to be minister to Switzerland but did not succeed, says that no more ministers nor consuls to foreign countries will be appointed from Indiana by the administration. This must be sad news to various individuals from Indiana who have been hanging on the ragged edge of hope for some months past.

A LAW of Kansas requires all officials elected to give an itemized account of their expenses while electioneering for the office. Hack hire, bands, printing, etc., are down of course, but the item of "sundries" it is noticed never appears in the account. Who purchases the whisky and buys the votes the public are left to imagine.

**AETHEER MOBBER PUNISHED.**  
 The trial of Clark, the second on the list of the ten men indicted at Lafayette for mobbing ex-priest Rudolph, terminated last week, in his sentence to four years imprisonment in the penitentiary and a fine of \$2,000. This is severe but no doubt deserved. A jury of twelve unprejudiced men after hearing all the facts pro and con consider that the punishment is deserved, and therefore we are compelled to accept their verdict as just, correct and fully merited by the defendant. The verdict is a defense of free speech in a free country, and should be far reaching in its influence. It will be a warning to many men seized with the fanatical idea that a speaker whose utterances may not accord with theirs in matters of religion must be beaten, abused and assaulted. They may do this in governments across the water but not here. In religion, politics, education, etc., opinions must be free and the right to express them untrammelled. Clark was a man of some influence, was an official of Lafayette, and his conduct in this instance that much more reprehensible. The other eight men engaged in the mobbing of the ex-priest can do nothing better in the case than to plead guilty and throw themselves on the mercy of the court, and learn their doom without further delay.

**THE "306" RE-UNE.**  
 The 306 idiots who wanted to have one man President of the United States for 12 years, that is those who are living, have organized for the purpose of having yearly reunions. These 306 delegates favored Grant for a third time for President in the National republican convention at Chicago in 1880, but the better sense of the convention triumphed over them and they, under the leadership of Conkling, were finally compelled to beat a retreat. These kind of men, hero worshipers, would probably, under certain circumstances, favor a civil monarchy and the installment of one man in the office of President during life. Such individuals would do more credit to themselves by desiring that their folly sink into oblivion than that it be kept in memory by yearly reunions. It is to be hoped that hero worship will never again become so intense in the history of this country as to desire any man to be President as long as these 306 desired Grant. Eight years is too long for any man to be occupant of this high office, and we trust that Cleveland is the last man, democrat or republican, to ever be in control that length of time again. Four years is long enough.
