THE WILHITE ESTATE
The Relatives of Mrs. Margaret Wilhite Fare Well.
Paschal Wilhite and wife, who resided a greater portion their lives on their farm, near New Market, were well-known throughout the county. Mr. Wilhite died about two years ago, and his wife, Margaret, followed him to the beyond a short time ago. During their lives, they were tireless workers, economical almost to denying themselves common necessities, and left a large amount of cash and land to be distributed among the heirs. During his life, although Mr. Wilhite was known as being rather close, he was always ready to help a man in distress or close circumstances, who showed industry, economy and a disposition to do the square thing. Many were the deeds of human kindness performed, known only to himself and the recipients of his benefactions.
By the terms of the will of Mrs. Wilhite, lately admitted to probate, there are 17 relatives who are cash beneficiaries, receiving amounts, ranging from \$200 to \$2,000. These legacies aggregate \$12,550. The New Market Baptist church received \$800 of the above amount, and Sarah E. Blake \$500 for kind services rendered during Mrs. Wilhite's last illness. By the terms of the will the real and personal property is to be turned into cash by the executor and the residue, after all debts incident to the execution of the will are paid, turned over to relatives specified in the will.

Death of John C. Winger.
Consumption gradually reduced the vitality until the spirit of John C. Winger took its flight at 8 o'clock Monday morning, at his residence on south Walnut street. The dread disease became fastened on him two years ago after a prolonged siege of la grippe. He was just entering on the period of well developed manhood, having passed his 31st birthday the 9th of this month.
In 1885 he was married to Miss Mollie Hicks and with his young wife emigrated to Eldorado, Kan., where he became one of the leading school teachers of the State. Seeking in vain to recover his health in Colorado, he returned to this city last fall to spend the remainder of a life, that, until disease took a firm hold, had a bright future before it. He became a member of the Christian church at Ladoga, his old home, at 11 years of age. He was a member of the Knights of Pythias lodge, of Eldorado, and which has sent him sick benefits to the amount of \$16 per month since he became disabled. The lodge of this city accompanied the remains to the train in a body on Wednesday afternoon and the Ladoga lodge had charge of the burial service, at which place the remains were taken for interment. The wife and five-year-old son are left to mourn, but they are among friends who will lighten their sorrows.

Poisoned by Eating Pressed Chicken.
A special from Waynetown on Monday gave the following details of a family being poisoned at Hillsboro: "Yesterday at Hillsboro Dr. Hays, his daughter Vonia, Mrs. Rivers, his mother-in-law, Cora Campbell, a young lady studying with the doctor, were all poisoned by eating 'pressed chicken.' Vonia, the daughter, stayed home from church and ate some of the chicken about 10 o'clock. By 11 o'clock she was vomiting and cramping so severely that her father was sent for at church. He dosed her up till noon and then the above named persons together with George, the colored man who stays there all at heartily of the same kind of food, which by 2 o'clock worked on all of them alike. Every one vomited, cramped and finally purged. Dr. Hays and his daughter were given up as dead, or about so, for a time. The colored man and the old lady were in a critical condition, the hired girl getting off the easiest. Dr. Hurt and Dr. Stout were hastily summoned and by means of stomach pump, antidotes, etc., succeeded in saving them. They worked till midnight without ceasing. All were improving this morning. Still Dr. Hays, his daughter and mother-in-law are in a critical condition yet."

Something About Pensions.
The democratic administration is making a very commendable pension record, the republican press to the contrary notwithstanding. Eld D. P. McClain, the superannuated preacher, residing on east Market street, has received a substantial increase of from \$16 to \$50 per month and \$100 back pay.
J. Ellis, of Waynetown, whose pension was suspended under the Harrison administration has been restored to the list and his increase also granted. He received back pay to the amount of \$400.
Jacob Everson, of Union township, has received an increase of \$5 per month and still the good work goes on. We could cite many other cases of like character, but the foregoing are sufficient to show that the democratic administration is doing its whole duty to the brave old soldiers and putting to shame the malicious falsehoods promulgated by the republican press all over the country. The truth will out and the boys who wore the blue are daily seeing this axiom verified.

FROM WASHINGTON.
STILL WORKING ON THE TARIFF BILL.
Rumors That Good Progress Has Been Made—Contested Election Cases in the House—Conferring About Behring Sea.

WASHINGTON, March 19.—There was no Sabbath quiet at the Capitol yesterday, because the democratic majority on the finance committee was there working over the tariff. Some of the discussion was over sugar some over the bonded period, some over the proposed abrogation of the Hawaiian reciprocity treaty, but more of it over various schedules and the valuation of packages in the administrative sections. The statement given out is that most of the differences were harmonized and that the majority will be able to present many of the completed schedules to the full committee to-day. Chairman Voorhees is still confident that the revised bill can be put into the senate to-morrow afternoon, or at the latest Wednesday morning. Since the understanding has been reached that the bill is not to be called up till April 2 the republican members will join with the majority in getting it out of the committee at the earliest possible date.
Most of Senator Allison's amendments in the administrative sections have been adopted by the majority. There is still some contention over the valuation to be placed on packages or coverings. Senator Allison has pointed out that the provision in the house bill caused great frauds under the tariff of 1893, whereas the section of the McKinley law relating to customs have, it is said, been satisfactorily administered.

HOT DEBATE PENDING.
It Will Arise on House Contested Election Cases.
WASHINGTON, March 19.—As soon as the sundry civil appropriation bill is disposed of the house will take up the four contested election cases—the O'Neill-Joy case from the Tenth Missouri District, the Williams-Settle case from the Fifth North Carolina, the English-Hilborn case from the Third California, and the Watley-Cobb case from the Fifth Alabama. The O'Neill-Joy and English-Hilborn cases, which were both decided against the sitting members (Reps.) by strict party votes in the committee on elections, are the most important, and will require the major portion of the time. If the contested election cases are disposed of this week, which is hardly probable, as the republicans will doubtless insist upon a democratic quorum, the house will proceed with the consideration of either the military academy or consular and diplomatic appropriation bills.
In the senate it is probable the fortifications appropriation bill will be reported this week. There will be an effort to dispose of the government printing site, the Russian thistle appropriation, and the McGarran bill, and of a large number of special bills on the calendar.

Supreme Court Full Bench Cases.
WASHINGTON, March 19.—The Supreme court of the United States will soon take up and hear arguments in those cases which it has been desired shall be heard before a full bench. The court has set the Indiana tax cases for a hearing before a full bench the 28th of March. Among the cases assigned for hearing April 9 is the interstate commerce commission against Brinson, from the northern district of Illinois; ex-Senator Edmunds appears in this case as the special counsel for the commission. There are upwards of twenty more cases awaiting argument before a full bench, but up to this time no steps have been taken to assign them for hearing.

Hatch's Bill Soon to Be Reported.
WASHINGTON, March 19.—Mr. Hatch and Senator Washburn say they are going to have Internal Revenue Commissioner Miller before Hatch's committee to-day to explain how the proposed tax could be collected. "The anti-emption bill will be reported this week," said Farmer Hatch. "I will not say whether it will be Monday or Saturday, but it will be some day before next Sunday. We will not have to wait five or six weeks, by any manner of means."

Conferring About Behring Sea.
WASHINGTON, March 19.—Secretary Gresham and Ambassador Pauncefote are holding daily conferences over the Behring sea regulations. It is understood the present bone of contention is whether the modus vivendi is to be extended another year. Pending the settlement of this question all instructions to American naval vessels in the Arctic seas have been withheld.

Denver Union Depot Burned.
DENVER, Colo., March 19.—The union depot was discovered on fire about 12:30 o'clock Sunday morning in the second story, and spread with such rapidity that by the time the fire department arrived the blaze lit up all the lower portion of the town. The entire structure, extending from Sixteenth to Eighteenth streets, was destroyed. The building was of stone and was owned by the Union Depot company. It cost \$250,000; fully insured.

Was With Perry in Japan.
New York, March 19.—Commodore Whiting, U. S. N., retired, who now is dying from injuries received when run over by a cab last January, was one of the officers of Commodore Perry's expedition to Japan and was the first American officer to set foot on Japanese soil. He is 70 years old.
