The jury in the case of Mrs. Cordeia Coleman, of Boone county, indicted for burning property belonging to her divorced husband, brought in a verdict of acquittal. Mrs. Coleman has still another suit to face, her ex-husband demanding damages for losses incurred.

Upon an affidavit filed by Marshal Grimes, Ramey Constance, who clerks at Stan Keeney's drug store, appeared before Mayor Bandel on Monday and entered a plea of guilty to the charge of selling liquor on Sunday. The fine and costs amounting to \$19.40 were promptly paid.

Hultz, on the day preceding last Christmas, for destroying the sanctity of his home, was acquitted by a jury at Vincennes last night, where the case was transferred on a change of venue. The plea of the defense was temporary insanity, and nine physicians testified that Willis' mental condition was disturbed by grief and shame for weeks previous to wreaking vengeance on the destroyer of his home.

Capt. David F. Allen, a lifetime resident of Frankfort, and one of the most prominent citizens, will shortly remove with his family to Michigan City, where he has been made president of a large manufacturing company.

The headquarters of the locomotive firemen's association of the United States is to be moved from Terre Haute. Only for the fact that that city holds the champion running record her grief would be difficult to bear at this last stab at her prosperity.

At the annual reunion of the Tenth Indiana regiment, held last Wednesday in Lebanon, about 150 members responded to the roll call. It was decided that the next reunion would be held on Chickamauga battlefield, Sept. 19 1895. Capt. J. B. Shaw, of Lafayette, was re-elected secretary of the regimental organization.

Since the beginning of the school year the parents of a number of young ladies have taken them to DePauw, Indianapolis and other points to attend schools where co-education is the rule. If such were in force at Wabash college the young ladies or most of them would remain at home to attend school instead of going abroad.

Barnum's show exhibited at Terre Haute on Wednesday and is now moving east. Ringling Brothers exhibited at Attica on Thursday. J. H. LaPearl closes the season next Saturday and goes into winter quarters at Danville, Ill. Mr. LaPearl is several thousand dollars ahead from this year's business, in spite of hard times.

In his flag dedicatory speech before Lee S. Warner's clothing house last Saturday afternoon, Hon. M. D. White paid a high tribute to the men who delighted in doing business under the American flag. As the stars and stripes were run up to the top of the staff to be unfolded and held aloft by the autumn breeze the crowd cheered lustily and the band struck up "The Star Spangled Banner."

Jack Flynn has been experimenting with wheat as feed for hogs, and is more than satisfied with the result, and gives the figures to prove that there is money in it. He fed 110 bushels of ground wheat made into slop to 29 hogs. This feed was consumed in thirty-three days and the gain in weight of the hogs was 2,110. Counting hogs at \$6 the price offered for them on Friday, Mr. Flynn nets a fraction over \$1.15 for his wheat.

The fair at Bridgeton, Ind., this year was not a financial success. The premiums are paid at 10 cents on the dollar. Exhibitors at the Rockville fair had still less, getting no payments whatever.

The funeral of the late William Rush, whose death occurred some time ago, will be preached at Union church, six miles south-east of this city, tomorrow by Elder Nye. In the evening Mr. Nye will deliver an address before the Knights of Pythias, at the Methodist church in New Market.

Considerable excitement was caused at Colfax last week by striking a strong flow of gas on the farm of Mrs. Parish. Workmen were driving a well and the drill was thrown about 140 feet when a rushing noise was heard and mud and water was thrown 30 feet in the air. A match was applied and the flames shot up almost 50 feet. It was found necessary to move the derrick and other things away in order to keep them from burning. It was both a sad and singular coincidence that the Sunday train from Chicago bore the remains of two former citizens of Crawfordsville. RIOT OVER THE NOMINATION

Followers of Candidates for Congressional Honors Engage in Fight.

MEMPHIS, Tenn., Sept. 24.—A riot occurred at Gatlingburg, Tenn., last night between the partisans of John C. Houk and Henry Gibson, rival republican candidates for congress. While Congressman Houk was addressing a large audience in the Baptist church several of Gibson's supporters attempted to howl him down and great excitement followed. During the confusion Deputy Sheriff Seaton entered the church with a warrant for one of Gibson's leaders for pistol carrying. As he grabbed his prisoner some of his followers jumped on the deputy and a fight began. Pistols were flourished, stones thrown, and fifteen fought like tigers for several minutes. When the law conquered it was found Avery Codill, leader of the Gibson men, had his skull crushed from blows from the butt end of a pistol and Redmond Maples, who had been summoned by the deputy, also had his skull crushed. Both of them are fatally injured. Several others were seriously injured.

They Want Their Wages Doubled.

NEW YORK, Sept. 24.—The Hebrew speaking shirtmakers of New York, 3,000 strong, went on strike yesterday and 200 shops were deserted save by the employers, many of whom spent the day figuring out how best to effect a resumption of profits without an increase of expenditure. At a meeting resolutions were adopted declaring that before the strikers go back to work contractors and manufacturers must raise wages on piece work to the old scale, which is the present one; that they must deposit \$200 each with the union as a guarantee of payment of wages, and \$100 as a forfeit in case of any reduction during the next six months. The struggle probably will be a long and bitter one.

BAD STATE OF AFFAIRS IN PERU.

LIMA, Peru, Sept. 24.—Gen. Bonilla is marching through the country declaring martial law. The government is in need of money. Foreigners and natives are being asked to contribute. In order to buy ammunition the government is trying to raise money by mortgaging its property. Business is bad. State of Affairs in Peru.

STURGIS, Ky., Sept. 24.—While there has as yet been no formal outbreak over the proposed attempt to collect the railroad tax, serious trouble is looked for to-day, when Collector Thomas C. Blackwell is expected to begin his job. Another shipment of guns was received here yesterday, and the organization of the citizens may be said to be perfect.

SCRANTON, Pa., Sept. 24.—T. V. Powdery, the noted ex-labor leader, will be formally admitted to the bar of Lackawanna county to-day. He has about determined to open a law office in New York city and locate there.

BIRMINGHAM, Ala., Sept. 24.—The grand jury has indicted twelve of the alleged leaders in the Pratt mines massacre of July 16, when Deputy Sheriff B. W. Ticer and several negro miners were slaughtered by

Killed by a Northwestern Train.

MILWAUKEE, Wis., Sept. 24.—The Chicago & Northwestern train to St. Paul struck a buggy at North Greenfield last night, instantly killing Gus Miller of Ripon and severely, probably fatally, injuring Gus Krumbolt of North Greenfield.

Makes a 24-Hour Record.

WASHINGTON, Sept. 24.—J. J. Fister of the Georgetown Cycle club made a new American record for 24-hour road riding last evening at 6 o'clock, having ridden a distance of 311 1/4 miles, which is eleven miles more than any previous record.

Fear a Revolution.

BOGOTÁ, Colombia, Sept. 24.—It is feared a revolution will be unavoidable on account of the death of President Nunez, as there will be a number of candidates for the presidency unless the vice-president obtains control.

WABASH, Ind., Sept. 24.—A meeting of manufacturers here expressed the sense that it would be better to go back to coal than pay the rise in price of gas from 5 to 7 1/2 cents a thousand.
