But May Be Induced to Take Some Less.

Miss Rosa Dean, through her next friend W. H. Dean, entered suit against the commissioners of this county last week, demanding the sum of \$20,000, for damages, as she avers through the negligence of the county in not keeping a road, over which she was traveling, in proper repair. The road is between Ladoga and Jamestown, and about a year ago in traveling over it at the bridge over Jackson creek there is an ungraveled approach, the embankment being fifty feet high; that as she drove along this embankment her horse took fright and, whirling, threw the buggy over the embankment, which she negligently been left unguarded, that the plaintiff, by being thrown from the buggy and down the steep incline, received certain and incurable injuries from which she still suffers great bodily and mental distress. Suing for such fabulous amounts is one of the strange fancies of many people who want damages from a state, county or corporation. Why not make it \$100,000 at once so when one gets it they can retire forever from worldly cares? When the plaintiff recovers this sum from Montgomery county she can buy a big farm and invest in bank stocks—when she gets the money we mean.

The Gas Supply.

Inspector Leach, who has just made a tour through the gas belt gives a rather hopeful view of the situation. In an interview he says: "Experienced men are now at the head of nearly all companies, and I believe the service will be more satisfactory than it has been. I have notified all gas companies, that they must take steps to harbor the supply of gas. There must be no waste from this on. There has been a great deal of gas wasted in Indiana. I have been in office four months, but I am convinced that gas will last much longer if we take care to save the supply. I have stopped the waste in several towns where flambeaus were being burned. In one or two places I found a vast quantity of gas being wasted daily. It is probable that I shall have to make a few prosecutions in this country. The gas can be harbored under the law—which it is not—it is not my fault; I purpose to see that it is enforced to the letter."

"Is the supply of gas failing?"
There has been no sudden diminution in the supply, nor is there likely to be. You know that when gas was discovered the pressure was about 320 pounds. It is not that now. The history of our gas field will, I have no doubt be a repetition of every other gas field. I do not suppose anyone expects anything else. The gas will not last always; but if we are careful with the supply, I see no reason why we should not have gas for many years."

Closed Publication.

After an existence of six months the Morning Daily Herald ceased publication on Saturday last. Dull business and an already over-crowded field are the causes of its suspension. The Herald was a spicy publication, gleaned the field of news very thoroughly, yet there is no room in Crawfordsville or this county for three daily newspapers. It is questionable if any publisher in the county is making anything more than a living, making money being another thing, hence the demise of the Herald is not to be wondered. The material of it will probably be moved by Mr. Boyland to another city and opened anew for business.

Shortly after his departure from Terre Haute the Pinkerton agency traced him to New Orleans, from there to New York and then to this city, where he has been traveling under the name of T. J. Franklin. The Pinkerton men and the local detectives have been hounding him for the past four days and they did not bag their game until last midnight, when he was caught in a boarding house.

Gambler Taken In.

A number of young fellows around town who take pleasure in the festive games of seven-up, poker, craps, etc., and love to win a few dimes or dollars where they are more easily obtained than by hard work, when obtained at all, were taken in on Saturday night and Sunday afternoon. Saturday evening a game was discovered in progress in a room in the frame building south of Gilbert's bakery on Green street. Six young men were captured and taken to jail. On Sunday afternoon five young men were "tired" in a stable between Pike street and Wabash avenue. Officer Egan Banister marched them to jail. Monday morning they were taken before the mayor and fined, the fines amounting to over \$15 each, some paid, while others staid theirs.

Number of Voters.

The state auditor has completed the enumeration of voters of every county in the State. The enumeration is taken once every six years, under the direction of the township trustees, in order that it may be submitted to the legislature as a basis for apportioning the State for legislative representation. This year's enumeration shows that there are 627,072 voters in the state. Of this number, 613,750 are white and 13,322 colored. The following is the number of voters of Montgomery county according to the report: White voters 8,356, colored 97, total 8,452.

Leg Amputated.

Dr. A. S. Henry, of Alamo, but for a long time a resident of this city, was compelled to have a leg amputated at Indianapolis last week to prevent threatened mortification of the limb. His leg has been in a diseased condition for several months. The amputation was performed at Indianapolis at the St. Vincent hospital.

State Soldiers' Home.

The Soldiers' Home at Lafayette has been opened for the reception of veteran soldiers under certain rules and regulations. Among them, we understand, is that soldiers receiving \$12 per month pension or over are not desired. Capt. McGrew, of Indianapolis, has been appointed manager.

Alex Mahorney is disposing of his furniture and queensware quite rapidly and expects to close up his business here within ten days. He will move either to Alexandria or Montpelier, the place to be determined next week.

Who May Sojourn at the New Home Provided by the State.

The members of McPherson Post, G. A. R., at a meeting on Saturday evening determined to ask the county commissioners for an appropriation to construct a cottage for the veterans from this county who may sojourn at the new home near Lafayette, which the State has provided for them. The following resolution was passed at the meeting:

RESOLVED, That a committee of five comrades be appointed by the Commander of this Post to present the proper petition to the board of commissioners of Montgomery county and in behalf of the needy and destitute veterans, and the poor and homeless wives, widows and mothers of the ex-soldiers of the republic urge the commissioners to make an appropriation of six hundred dollars (\$600) for the erection of a cottage at the home, to be known as "The Montgomery County Cottage."

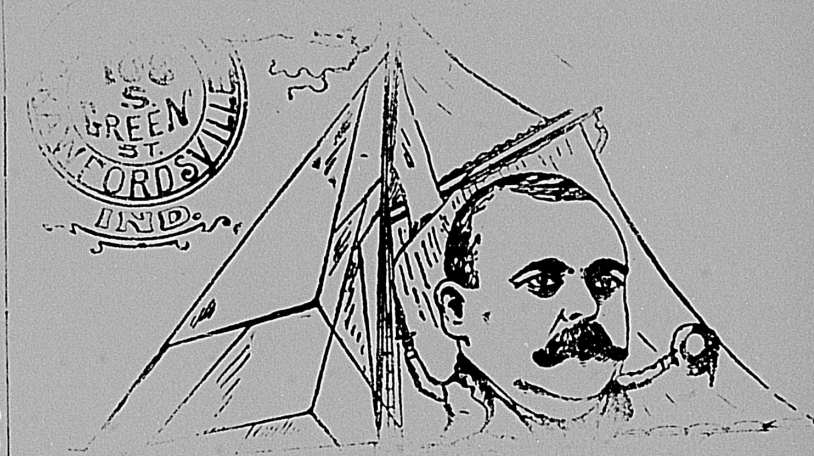
