SHERMAN'S RESOLUTION.

Senator Sherman in the Senate the other day introduced the following resolution:

"Resolved, That by injurious legislation by the Fifty-third congress the revenues of the government were reduced below its necessary expenditure and the funds created by law for the redemption of United States notes has been invaded to supply such deficiency of reserve; that such a misapplication of the redemption fund is of doubtful legality and greatly injurious to the public credit and should be prevented by restoring said fund to the sum of not less than \$100,000,000 in gold coin or bullion, to be paid out only in the redemption of United States notes."

Senator Sherman among his admirers has the reputation of being an able financier. So far as "feathering his own nest" he perhaps is, but any number of his financial theories have proven weak, and have had to be abandoned. His silver purchasing act which was a law until knocked out some three years ago, many believe aided in bringing about the panic of '93, and strong evidences of which are still around and about us. A wise, judicious financier does not generally indulge in temporary expedients. Sherman is probably a good financier for bankers, bond buyers and note shavers, but a very poor one for the country at large. There is a vast difference between the two classes. There is a vast difference between a politician and a statesman. One is for himself, the other is for the people. Sherman is very poor authority to be quoted on finance. His actions denote him as acting and shaping his work on financial matters strictly for one interest—the gold interest. We want financiers of broader views than Sherman to enact laws governing monetary matters.

GOWDY VS. NEBAKER.

The war between these two gentlemen for the position of chairman of the republican State central committee, if reports are correct, though quiet is energetic and determined. Gowdy has been chairman for some years past and wants to continue. He makes the assertion that the attempt to oust him comes from a ring of politicians hanging around the hotels at Indianapolis and a few bankers through the State who have pecuniary reasons for opposing him. Nebaker is the favorite of most of the politicians, because he is unscrupulous in political warfare and will countenance any dirty scheme that has a prospect of a favorable termination. Gowdy is reported as a much more honorable politician than his opponent. The friends of each side are saying many bitter things of each other and the friends respectively of Fairbanks and McKeen, candidates for U. S. Senate, are likely to be involved in the muddle. In the fight going on demoralization to the party it is feared will be engendered, which would be sad indeed, when the number of political schemers and tricksters are to be taken into consideration.

WELL ATTENDED.

The democratic conventions through the state last Saturday were generally well attended, stirring speeches made, and considerable enthusiasm manifested. For a start everything passed off satisfactorily, and a strong interest seems to be shown. The democracy of Indiana have only to be united this year and victory is assured. It makes no difference about the Harrison influence in this State, and the amount of money the republicans intend using to seek to carry the State, if democrats, those who are such from the principles upon which the party is founded, will be harmonious and united, we can carry the State. We have had a good beginning. Let us continue on that line. The great defeat the democracy met with in '94 was brought about by themselves by absenting themselves from the polls or scratching their tickets in favor of the opposition. This should not and will not occur again.

NOMINATE A TICKET.

The Prohibition party of the State is going in a few weeks through the monkey performance of nominating candidates for governor and other State offices. Of course they do not now nor at any time in the future expect to elect anything. The nominations, however, satisfies the vanity of a few of their leaders by enabling them to see their names in print, and gives them an opportunity to appear before the people occasionally. The Nicholson law has made the State as near prohibition as it will probably be in many years, and the party will have to accept that as their platform or nothing. The extreme radical legislation that they want they can never have, at least in this age.

STATE OFFICERS FEES.

Through the fee and salary law of the State and the legal phases of which have gone through all the courts it is pronounced all right. State officers are not hereafter to live on "clover" as in the past and will hereafter be paid in proportion to what they are worth, and no more. State treasurer, auditor and secretary of State, get \$6,500 per year, and no "perqs" are to follow. By the time they pay household expenses and deputies they will not have very much left to speculate on change in Chicago, or buck the tiger in gambling rooms as they once did in those "good old times," that many may sigh for but which will return no more. The Attorney-General is another individual that is badly rotted by the new law. That official is to get \$7,500 and no more. Baldwin, Green, Smith and other attorney-generals of past years made fortunes out of the office in one term. Their fortunes came directly from the school fund too, from the large per cent paid for collecting fines, forfeitures etc. State treasurers and auditors in former years thought nothing of making from \$15,000 to \$25,000 per year from their positions. Badly constructed laws or no laws at all frequently enabled them to do so. But these times are past both with State and county officials. That they will never again be enabled to make the money from their positions as in former years is a pretty well settled fact. The people will not submit to it, and will quickly consider that any official not satisfied with the prescribed salary should at once resign. There are others at all times anxious to take their places.

THE VENEZUELAN COMMISSIONERS.

The President has appointed the following individuals as commissioners to act regarding the boundary line between Venezuela and British Guiana:

David J. Brewer, of Kansas, justice of the United States supreme court.

Richard H. Alvey, of Maryland, chief justice of the court of appeals of the District of Columbia.

Andrew D. White, of New York.

Frederick R. Coudert, of New York.

Daniel C. Gilman, of Maryland.

It will be the duty of these gentlemen to investigate thoroughly into the matter from the time Guiana passed into the hands of the English from the Spaniards and ascertain if the English have encroached upon the rights of Venezuela. It will require some months before the commission will make a report as a large amount of research and investigation will be necessary.

What it may all amount to is the question. England may pay little or no attention to it and continue on in her plan of aggression. The United States is interested in the matter only so far as there may be a violation or trampling upon the Monroe doctrine. The report may be the foundation upon which war with England will be declared, or it may be ascertained that that country is only demanding her rights in the premises. However the report of the commission will be awaited with much interest.

MORTON A CANDIDATE.

It is announced that Gov. Morton, of New York, who was vice president under Harrison, will be in the race for the nomination for presidency at the republican national convention at St. Louis in June. This makes five candidates in the field now, and the names of others may appear later on. Morton is better equipped than any of them in one respect. He has a "barrel." He has plenty of money, is several times a millionaire. That is the main incentive with most of the party, and with large numbers of the delegates will be uppermost in their minds. At the Minneapolis convention it was noticed that many of the delegates sold their votes. They will do so again, and no man can give a higher price for them than Morton. In the contest which promises to be prolonged, he will need them. It will be in the selection of a candidate a case of "barrel" as the contest wages hot along the line, and the eastern friends of Morton will, without question, be supplied with plenty of munitions of war to secure their man.

WHEN Dr. Stott, of Franklin college, declaimed at the meeting of the Indiana college association that the course of study laid out by the state board of education is "unfair, and that its effect, if not intent, is to send all high school graduates to the State university," to the detriment of colleges of higher standards he stated a truth which is patent among college men the state over. And, with equal truth, he could have said even more surprising things about the methods which are used in behalf of the State university, the institution that all the people are taxed to support though a large majority prefer to send their children to other schools.

SENATOR SHERMAN has been out of public office only one day in forty years, but that is enough to put Senator Morrill ahead of him. Both entered the House in 1855, and there has been no break in the continuity of the Vermont statesman's service since. Morrill holds the country's record for continuous service in Congress.

If increased revenue is necessary, which is doubtful, congress should establish a tax which would be the least possible burden on the people, and would produce the greatest possible cash results. The republican plan in congress is to renew the protective tariff for revenue purposes, which would realize ten dollars for the manufacturer whose product is protected by the tax, while the country would get about ten cents in revenue.
