The Camden Murder.

Speaking of the killing of Mrs. Nipple, who was murdered near Camden, Carroll county, last week, a correspondent says:

Mrs. Nipple lived two hours after the shooting, and although it has been generally reported that she failed to recognize the man who fired the fatal shot, subsequent developments tend to show that in her ante-mortem statement to Mat Lannon and two other neighbors she disclosed the identity of the man responsible for her death. His name has not been made public, but the Carroll county authorities have seen fit to arrest Daniel Neible and two sons, twelve and eighteen years old, respectively, and hold them without bail pending a preliminary examination which will be held Saturday morning. The fact that the murdered woman was a widow with a large family dependent upon her has had the effect of arousing public indignation to a dangerous degree.

The morning after the murder over two hundred men collected from all parts of the county and a bloodhound was put on the trail. A heavy rain, however, had destroyed the scent and the dog failed to trace the guilty man. The crowd had a rope and was evidently prepared for a hanging. Mob law is not unknown in Carroll county. Several years ago Amer Green was lynched for the murder of Luella Mabbitt, and a year ago Ben Whitmore, a traveling horse-trader, who killed Edward Leary in a drunken quarrel, narrowly escaped a like fate. If anything of an unusually incriminating nature is developed against the Neibles to-day trouble is likely to occur. The preliminary will attract many people.
