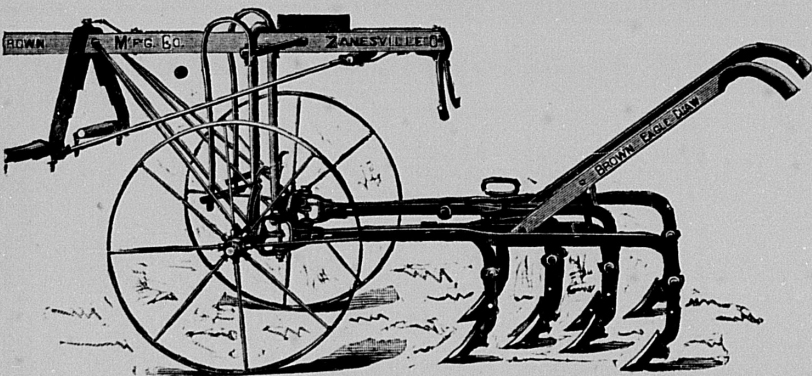

Notice is hereby given to the citizens of Brown township, and of the towns of Wave and Montgomery county, and State of Indiana, that I, the undersigned, a male person over the age of twenty-one years, of good moral character and a continuous resident of said Brown township and town of Waveland for more than ninety days immediately preceding the giving of this notice and filing of this notice of application, will apply to the Board of Commissioners of said county at their next regular session to be held on and held on the first Monday in June, 1897, for a license to sell all kinds of "spiruous, vinous, malt and intoxicating liquors" in a less quantity than a quart at a time to be drunk on the premises where sold.

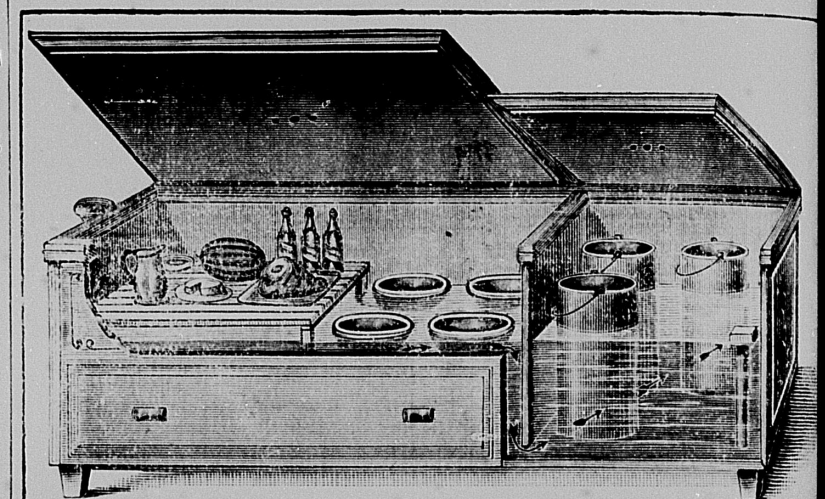
