the Hanly meeting there tomorrow.

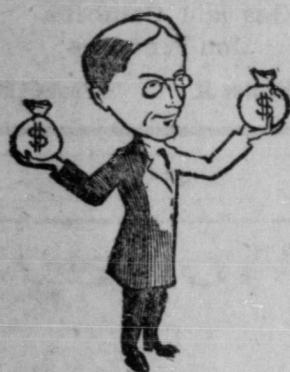
About thirty people from Portland

A "magic healer" who claimed to

out a license. It was held by the
Georgia Court of Appeals in Bennett
vs. Ware, 61 Southeastern Reporter,
546, that while he was not practicing
medicine within the statute which pro-
vides that the words "practice medi-
cine" shall mean to "suggest, recom-
mend, prescribe or direct for the use
of any person, any drug, medicine,
etc., for the cure, relief, etc." the
physician who caused him to be prose-
cuted was not acting in bad faith so
as to be liable for malicious prosecu-
tion.
