## SLIGHTLY DISFIGURED BUT STILL IN THE RING

Chairman Mack, of the Democratic national committee, said that while the Democratic defeat in the east was crushing, the party had won substantial victories in the west. The national organization would not go to pieces. On the contrary, plans would be made at once to strengthen the organization. Said he, "It is my intention to continue headquarters in Buffalo and Washington for the next four years, to keep in touch with the leaders of all the states and promulgate Democratic principles and Democratic thought by the printing of literature to aid the leaders of the party in fighting the high tariff which in all probability the Republicans will continue, notwithstanding their promises to reduce it. I am supported in this by the members of the national committee, state chairmen and other leaders all over the country. In his own state, Nebraska, where he is best known, Mr. Bryan was victorious. And while it is true that he met with defeat in the nation he did so as the candidate of his party, supported by the six or seven millions of his countrymen who voted for him and the principles so splendidly expounded and with the respect and admiration of the entire nation. Mr. Bryan made the most mag-

nificent fight ever waged by a candidate. The party was made the victim of misrepresentation, a misrepresentation that Democratic success would retard the business interests of the country. That was, of course, an argument without foundation in fact. Notwithstanding defeat the Democratic party stands more united today than it has in many years, and in this union lies its future strength and power of regeneration."

Hon. John W. Kern as expected, has announced his candidacy for the United States senate. It is true that Mr. Kern has long been a war horse in the ranks of the Indiana Democracy, and this fact will doubtless aid him to attain this place of distinction and honor.

It is freely predicted by Democrats and Republicans alike that Mr. Adair will have little trouble being elected to congress again in this district. With the going out of many of the factories in the gas belt the district is very close politically and with the evident fact that Mr. Adair has made many true friends in the republican party the chances for his re-election look mighty good.—Stafford Banner.

Steven B. Fleming carried Allen county for joint senator by a majority over Judge Vesey of 1,871, and his majority in Adams county was 1,291, making his total majority in the district 3,162. ## TWO DIVORCE CASES

Two Are Asked in Petitions  
Filed in Court this  
Morning

## THE OLD CAUSES

Otto Mathewson Accuses  
Unfaithfulness—Amanda  
Risen Abandonment

Two new divorce cases have been filed at the circuit court clerk's desk. The first was prepared by Attorney D. E. Smith and Otto C. Mathewson is the plaintiff and his wife Blanche Mathewson the defendant. They were married June 30, 1906, and on June 30th of the following year, Mrs. Mathewson went to her husband and told him that her brother had been fatally injured at Lima, Ohio, and that it would be necessary for her to go to him. She was given the necessary money, but instead of going to Lima, she went to Wapakoneta, Ohio, where she met some man, whose name is unknown, and soon afterward sent word to her husband that she had no further use for him and that he could get a divorce if he wanted to.

The other complaint was filed by Attorney C. L. Walters, and is entitled Amanda E. Risen vs. Samuel Risen. They were married at White Cloud, Michigan, December 27, 1898, and lived together for ten years, when the defendant abandoned his wife and children and has since failed to support or provide for them. It is also alleged that when he lived with his family he was a drunkard and often cursed and abused them. A divorce and the custody of the two children, George aged seventeen and Hazel aged eleven, is demanded.

## DECATUR BOY THERE

Charles Knapp Tells of the  
Many Surprises of the  
New City

Few people in Decatur realize what a city the great steel town of Gary, Indiana, has become. There is perhaps no doubt but that within ten years it will be the largest city in the state. In its two years of existence it has grown to nearly thirty thousand. Among its inhabitants is Charles W. Knapp, of this city, who graduated last spring from Purdue and is now employed in the electrical department of the United States steel corporation plant. In a recent letter he told of the wonderful future for that place and enclosed a clipping from the Chicago Tribune which in part told of the town as follows:

Just think what it means in a commercial way to spend \$100,000,000 within a radius of ten miles and within a period of less than ten years. That is what the United States steel corporation has begun to do in this vicinity, and no man can estimate the effect on business and politics at northern Indiana, and even over the line between Illinois and Michigan.

First of all, as to the commercial transformation which has been effected in this land of sand mountains, teal duck and pine barrens. There could not be a more unproving field than this old bed of Lake Michigan for a demonstration of the unlimited power of great capital to make a wilderness blossom like an American beauty, and by giving employment to many thousands of men to add to the comfort of the community.

How many people of Chicago knew what was meant when the great steel corporation announced that it proposed to secure possession of nine miles of water frontage on the southern shore of Lake Michigan, and dump out on the sand dune country \$40,000,000 before it should receive a cent in return or a single ounce of manufactured steel?

Do many people understand that today, but a little over two years after the ground was broken in one of the most forbidding wildernesses of the country, where the lake shore sand swamps entrap the feet, there are now 5,000 men at work and \$250,000 in cash at the least estimate is distributed every month? Words like "astonishing," "marvelous," "astounding," and "miraculous" seem entirely trite in describing the results reached by the preliminary millions already spent.

A city has grown up in the night. It is not a mushroom village with miles of temporary shacks and drink parlors, such as we were accustomed to see in the far west during the boom times, but a real city, with miles of well paved streets, water supply, sewerage, a host of daily paper, banks, hotels, street cars, and substantial buildings of brick and stone constructed with heavy foundations to permit an extension upward in the near days to come.

Here is a city where there are not homes enough to shelter the thousands of prosperous workmen, and every night and morning long trains pull them to and from their work, many of their homes being in South Chicago, Englewood, and intermediate towns. There are other industrial centers in northwestern Indiana like Whiting, Indiana Harbor and Hammond, but Gary is the newest and the most astounding of them all.

## WORDS OF COMFORT
