
MADE BAD THREATS

Harry Baker Became Intoxicated Yesterday and Tried to Secure a Revolver

SAID HE WOULD KILL

He Was Arrested and Given a Good Lecture by Officer Bohnke

Harry Baker, a young married man residing in the south part of the city, an employee at the Coppock Motor company, and when sober, a very clever and law abiding citizen, made several bad threats last evening while on a spree and as a consequence was arrested by Marshal Bohnke. Mr. Baker a painter by trade and a good one, became intoxicated yesterday whereupon a near relative notified liquor dealers not to dispose of any more intoxicants to him and the order was obeyed. This angered Baker and fraught with wrath he went to the hardware stores of the city where he tried to purchase a revolver, stating that he would shoot the man who interfered in his business. The hardware dealers of course refused to sell him the weapon and this added to his fury. At several times he threatened violence to his brother-in-law, it is said, while his wife lay at home hovering between life and death. Mrs. Baker has been ill for several weeks and it is reported that her condition is serious in the extreme. Baker was given a severe lecture by Officer Bohnke and was admonished that an
