ARE TWENTY-TWO MILLION

Milwaukee, Wis., Jan. 26.—There are 14,235,451 Roman Catholics in the United States according to the advance sheets of the 199 Wiltzius official Catholic directory, published in this city. The statistics are furnished by the archbishops and bishops of the United States after the taking of a census in all dioceses. Adding to the 14,235,451, the number of Roman Catholics in the Philippines, Porto Rico and the Hawaiian islands, brings the grand total of Catholics under the United States flag to 22,474,440, as compared with 12,053,000 Catholic subjects under the British flag.

Considerable Excitement as to the Coming Eley Trial

MEN WANT SEATS

To Hear the Trial—The Absurdity of Curiosity Seekers

A number of men who are included in the bald headed class, have spoken to Mayor France for seats in the front row tomorrow evening when in his court the misconduct of Mrs. Eley and young Harry Straub will be threshed out. The promise of sensational evidence in support of the weird charge instituted against Mrs. Eley by her saintly husband, has caused a mad rush for seats and even now it is said that standing room is at a premium. It would seem that American civilized people would turn their head in shame to think that one of the citizens is charged with such a serious charge, instead of scrambling for a seat to satisfy a curiosity and thus encourage wrong doing. IT IS NO ONE'S BUSINESS

No Right to Inquire Into What the President Does.

Washington, Jan. 27.—That the Senate has no right to call upon President Roosevelt for information which he may have obtained from the United States Steel corporation when he countenanced that concern's absorption of the Tennessee Coal and Iron company, is the opinion of the special committee on judiciary, appointed to investigate the merger. The situation is proving decidedly embarrassing to the judiciary committee, but, regardless of this fact, it has been decided to proceed with the inquiry and report to the senate whether the president had authority to permit the merger.
