BELIEVED THAT GERMAN REVOLUTION IS DOOMED

VON KAPP LOSES GRIP AS FORCES REFUSE TO RALLY TO CAUSE---HOPES TO FORM PRUSSIAN CABINET---EBERT STILL HOLDING ON.

BULLETIN

Paris, March 15.—(Special to Daily Democrat)—The French foreign office is informed in a dispatch by way of Mayence that Berlin newspapers announce that President Ebert and Dr. von Kapp have reached a compromise under which Ebert will remain president. The compromise according to the advices which are confirmed provided that Ebert shall form a cabinet of specialists and dissolve the national assembly.

Paris, Mar. 15.—(Special to Daily Democrat)—Latest information from Germany received by the French foreign office indicates that the revolutionary movement of Dictator von Kapp is doomed to failure.

The majority of socialists, democrats and even some sections of the reactionary element have repudiated the revolution, foreign office advices assert.

Von Kapp's final hope, officials believe, lies in the organization of a purely Prussian cabinet. The revolution, the foreign office advices indicated, has failed completely in all the provinces except western Prussia.

Extensive opposition to the German revolutionary government which seized power in Berlin Saturday, was indicated in today's early dispatches.

The Ebert government, according to a Dresden dispatch, has refused the request of the revolutionists to enter into negotiations. President Ebert was quoted as declaring the revolutionary group represents merely a few partisans who have seized power temporarily. Ebert, it was reported, has sent an emissary to Berlin to demand return of the central governmental powers.

Other dispatches said the Ebert groups have organized armed opposition in some cities. Fighting was reported in Kiel, Essen and Frankfurt. Gustav Noske, Ebert's defense minister, also was reported organizing military opposition to the revolutionists.

The general strike movement to embarrass the revolutionists also was reported meeting with success. The report of a strike of railway workers was considered significant. Workers in Munich have joined the general strike, the dispatch said.

The south German states, which always have opposed Prussian militarism, apparently have revived this opposition and will not recognize the revolutionists. The industrial districts, where socialists and radicals look upon Ebert as the lesser of two evils, also have refused to recognize von Kapp, the revolutionary dictator.

Berlin dispatches declared some members of the deposed government have come out in opposition to the revolutionists there.

Radicals have taken advantage of the general confusion to declare a soviet republic in the Hof and Schweinfurt districts, one dispatch said. The national assembly, it was said, has been called to meet at Stuttgart on Wednesday.

The allied governments apparently will take no active hand in the situation unless further developments render it necessary.

A Paris dispatch, however, said Marshal Foch had said that allied troops occupy the Ruhr and Essen industrial districts.

The Dutch government, an Amsterdam dispatch said, has reinforced troops guarding the former kaiser and crown prince.

Copenhagen, Mar. 15.—(Special to Daily Democrat)—The result of the plebiscite in the second division of Schleswig has been announced unofficially as follows, a dispatch here today said:

Germany—48,148.
Denmark—13,025.

REVIVAL CLOSES

Four Weeks' Campaign at Methodist Church Results in Much Good

WERE 134 DECISIONS

Evangelist Eddie Thomas Leaves for Linton, Ind., for Revival Work

The four weeks' revival service at the Methodist church closed Sunday evening after a very interesting and profitable campaign. The evangelist, Mr. Eddie Thomas, and the members and pastor of the local church are well pleased over the effort. The church was crowded at every service and the prayer-meetings conducted in the homes during the four weeks of the revival were well attended and much of the success of the work is accredited to these prayer-meetings.

There were 134 decisions in all. Many of these will unite with the Methodist church, and many of them will unite with other churches of their choice, almost every denomination coming in for a few. Hence all the churches here, and some in other cities will gain in membership as a result of the Methodist revival in Decatur.

The music, which was under the direction of the evangelists, was especially fine, and was one of the most interesting features of the revival. During the early days of the revival the expenses of the four weeks' service were taken care of by collections. This amounted to between \$300 and \$400. At the last day's services the collections and pledges all went to the evangelist, and it is believed will total between \$1,000 and \$1,200.

Rev. Thomas went to Linton, Ind., today where he will conduct a similar service.

Tomorrow night is to be Eighth grade night at the Athletic hall, the local eighth grade basketball team taking the place of the high school team in playing basketball games this week. At this time the Bluffton Eighth grade outfit will journey to this city and will meet the locals in a return game, the locals having suffered defeat in their city several months ago and are now out for revenge. Both teams are evenly matched, the score being close at Bluffton, and the local fans are promised the excitement of a high school contest.

The North Ward team will clash with the South Ward team in preliminary to the Eighth grade battle tomorrow night, a game which also promises to be a little out of the ordinary and a thriller. Several other preliminaries will be arranged, and the local fans are promised a night of real sport in the junior basketball circles. AGED LADY DIES

Mrs. John Fuhrman Died at Daughter's Home Early Sunday Morning

WAS 77 YEARS OLD

Had Lived in Vicinity of Friedheim All Her Life—Funeral Tuesday

After being a sufferer of dropsical affection several months, death relieved Mrs. John Fuhrman, at the home of her daughter, Mrs. Ernst C. Stoppenhagen, at 1:15 Sunday morning. Mrs. Fuhrman had been in poor health more than two years, at that time having broken her hip in a fall, and her decline since that time had been gradual.

The husband died two or three years ago, and since that time the deceased had made her home with the daughter, Mrs. Ernst Stoppenhagen, and Mrs. Ernst Gallmeyer, survive, together with a son, John Fuhrman.

Mrs. Ernst Fuhrman had been a resident of the vicinity of Friedheim all her life, and was a devoted member of the Friedheim Lutheran church. The funeral will be held Tuesday afternoon at 1:30 o'clock, sun time, from the home of the daughter, Mrs. Ernst C. Stoppenhagen, just across the line in Wells county, the Rev. Preuss of the Friedheim Lutheran church officiating.

A SOLDIERS' DAY

A good many people are in favor of giving an Old Home week in connection with the big fair and it would more than please the managers of the fair if such a combination could be effected. The managers assure a good, clean show for the week, and are of the opinion that the home-comers would enjoy the attractions immensely. The fair association is going to a heavy expense in putting on the event in this city and they have assured us that it will be equal to any state fair in the country, no matter if they lose very heavily financially, it being their ambition and desire to give Decatur a fair which will attract thousands of people to this city and will "put us on the map." A committee is now working on the details and if the citizens are in favor of an Old Home week, they will plan accordingly. Decatur has not had an Old Home week since 1912, and a good many want one given this year.

JOHN GERBER DEAD

Well Known Adams County Citizen Passed Away Sunday Afternoon

FUNERAL WEDNESDAY

Had Lived in This County Since 1853—Six Children Survive

Infirmities due to old age were the cause of the death Sunday afternoon of John Gerber, well known resident of this county near the Adams-Well county line Sunday afternoon. Mr. Gerber was born in Switzerland and came to this country early in life. He became a citizen of Adams county in 1853 and resided in the same neighborhood ever since. He was married in 1862 to Anna Hyerly, who died in 1919. Surviving children are Mrs. William Whitmer, Mrs. Oril Gilliam, Miss Sarah Gerber, Jeff, Jehu and Jess Gerber.

Funeral services will be held Wednesday morning at 8:30 o'clock from the Christian Apostolic church, near Bluffton.

ONE DEAD; EIGHT INJURED

South Bend, Ind., March 15.—(Special to Daily Democrat)—Mrs. Leola Suchanek, 37, is dead and eight others are seriously injured as the result of a street car crash here yesterday afternoon when a south bound Chicago, South Bend & Northern Indiana interurban plunged into an open switch near St. Mary's college and academy. The switch near the college had been left open and the local car was backing into the switch. The interurban car crashed into the local car, killing one woman and injuring eight others. Some of the passengers attempted to escape by jumping from the car as they saw the approaching interurban. All of the injured were on the local car.

LODGE RESERVATION TO ARTICLE TEN ADOPTED

SENATE REJECTS FRELINGHUYSEN AND KIRBY RESERVATIONS --- SUPREME COURT GRANTS APPEAL TO STATE OF NEW JERSEY TO INSTITUTE SUIT.

Washington, March 15.—(Special to Daily Democrat)—The senate today adopted the Lodge substitute reservation on article ten of the league of nations covenant. The vote was 56 to 24.

The substitute was adopted after failure of efforts to amend it and defeat of numerous other proposed reservations to article ten which is the keystone of the treaty struggle.

Washington, Mar. 15.—(Special to Daily Democrat)—The senate today rejected the Frelinghuysen reservation to article ten of the league of nations covenant. This was the first of the pending reservations to this article to be voted on. The vote on this resolution was 17 to 59 only republicans and democratic irreconcilables supporting it.

The reservation introduced by Senator Kirby to article ten was defeated.

The vote on this reservation was 31 to 45.

Kirby followed defeat of the reservation by offering the past reservation. This was quickly voted down by the senate.

Washington, Mar. 15.—(Special to Daily Democrat)—The supreme court today granted the application of New Jersey to institute a suit in the high tribunal attacking constitutional prohibition.

The court granted the state permission to file a bill of complaint against federal officials charged with the enforcement of prohibition. The proceedings are similar to those brought by Rhode Island which are now awaiting the final decision of the court.

The government asks that the appeal reaching the court be heard Monday, March 29. The object of the proceedings is to knock out the prohibition amendment of the Volstead enforcement law.

MEXICANS ARE FIGHTING

El Paso, Texas, March 15.—(Special to Daily Democrat)—Fighting between Villistas and Carranza troops has caused suspension of train service in some sections, according to reports reaching here today from Mexico. Small railway bridges have been burned by Villa's forces. Villistas alone the border near here claim the rebel leader has launched a new military campaign.

Joseph Williams, American mining engineer, arrived here today following his release by Villa, who took Williams prisoner at the holdup of a Mexican train on March 4th.

A NEW REVENUE OFFICER

Washington, March 15.—(Special to Daily Democrat)—William Martin Williams, solicitor for the department of agriculture, has been chosen by President Wilson to be commissioner of internal revenue. It was announced at the white house today.

The nomination probably will go to the senate today. Williams succeeds Daniel C. Roper, whose resignation becomes effective March 31. Williams is a native of Alabama and has seen several years in federal service.

Williams was born in Georgia. He is a graduate of Harvard law school and practiced in New York until 1917, when he became a departmental solicitor.

JOE MCCONNELL FIRST TO FILE

Joe McConnell, county recorder, was the first candidate to file his declaration of candidacy with the county clerk, he filing this morning. Mr. McConnell was appointed by the county commissioners to act as recorder until the next general election to fill the vacancy caused by the death of Andrew J. Case.

STEPPED TO LOW EDGE

Grand Rapids, Mich., March 15.—(Special to Daily Democrat)—"Methods by which Truman Newberry was elected to the United States senate in 1918, destroy the underlying institution which safeguards our nation," Judge Elchorn declared today in addressing the jury in the Michigan election fraud trial.

"We have seen in this case how the people of Michigan are 'allowed' to select their officers," he said. "A quarter of a million dollars was sent to elect a man to a position which in six years would pay only \$45,000." The attorney declared "our homes and property cannot be considered safe without a pure and sound government."

Judge Elchorn contended Newberry was in direct touch with the working of his backers all during the campaign and that he knew of the large sum being spent in his behalf.
