**E**IGHT years ago Mr. E. L. Martin entered into the manufacture of butter at Markel, Ind. He soon achieved a reputation as an expert in the science of butter making. Mr. Martin continuing the management up to four years ago when Mr. W. A. Klepper became associated with him. The firm then became known as The Martin-Klepper Co. Business grew so rapidly that soon after headquarters was established here in Decatur it was found necessary to establish a branch office and plant in Huntington, Ind., and for the removal of the Markel plant to Bluffton, Ind.

They now have three of the most modern, scientific and sanitary creameries in the country with an output of 4,500,000 pounds of butter annually. The Decatur plant alone producing over 15,000 pounds of Cloverleaf Butter daily. January 1, 1920, the three plants were re-incorporated for \$250,000 and were given the name of Cloverleaf Creameries, Inc.

Cream is gathered for the Decatur plant through the medium of nearly one hundred receiving stations scattered within a radius of one hundred miles. All this cream is pasteurized and clarified under sanitary methods obtainable, consequently the finest cream-

ery butter is produced which finds a ready market in all parts of the country. A great amount of it going to the best trade of New York City and Cleveland. A branch office has been established at No. 11 Harrison street, New York City, for the distribution of Cloverleaf Creameries products throughout the East.

The three plants of the Cloverleaf Creameries furnish constant employment to over 200 capable men and women; over 100 of them contributing their energies to the success of the home plant and main office here in Decatur.

TASTY ICE CREAM is another product which has already established a reputation for its fine flavor and superior quality. Large quantities are shipped daily to all surrounding towns and cities.

Modern machinery has been installed to take care of the enormous quantity of butter milk and now DRIED BUTTER MILK becomes a valuable by-product which is used largely by bakers all over the country.
