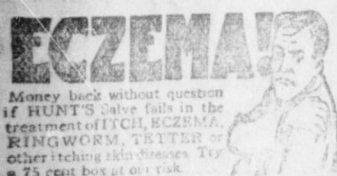

TWO WEEKS LONGER

Ossining, N. Y., April 30.—(Special to Daily Democrat)—Four men who were to have been electrocuted last night for the murder of ticket agent, were granted a two weeks reprieve by Governor Smith shortly before they were to enter the electric chair.

The reprieve was granted on recommendation of Supreme Court Justice Mitchell, who presided at the trial following a confession made by Joseph Milano, one of the quartet, in which he assumed full responsibility for the crime.

The confession made by Milano will be used in an application for a new trial for the other three men.

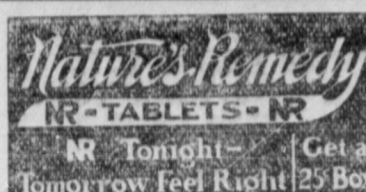

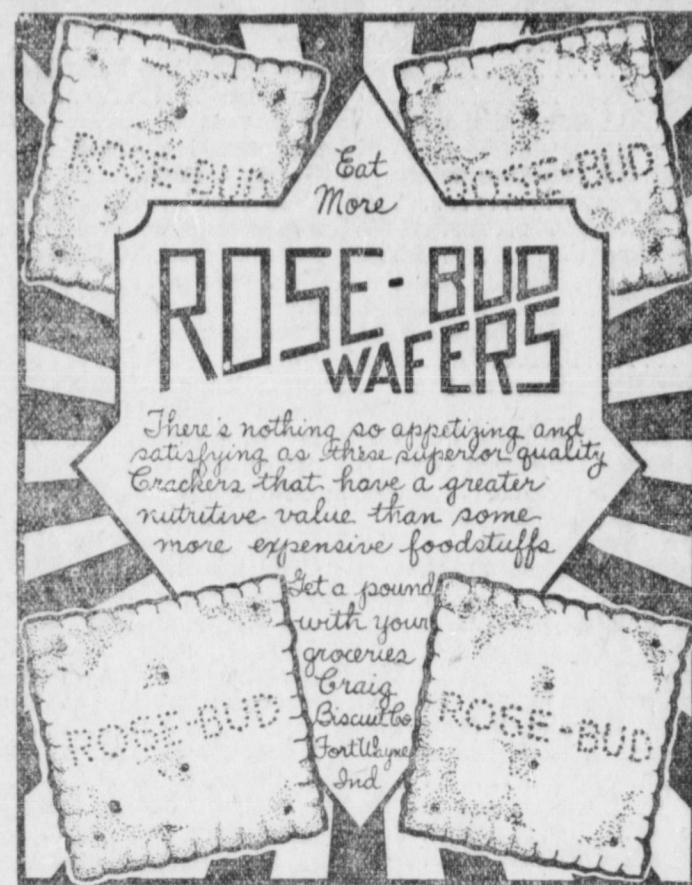
