wife, Julia Boese, all beds, bedding, bed clothing, furniture and household goods, of which he may be possessed at the time of his death.

Paragraph ten provides that the son Martin, shall be reimbursed by funds from the estate which he has paid for debts, funeral expenses, or tombstone, and directs that said executor shall divide remainder among the children, share and share alike. The children are: Martin, Reka, Mina, Anna, Martha and Charles.

Paragraph eleven gives the wife, for and during her natural life in view or her right by descent or otherwise in real and personal estate, the one-third part of all rents, income and whatever is produced from real estate owned by testator at time of his death.

Paragraph twelve gives and devises to the son, Martin, on condition that he carry out directions contained in items 2, 3, 4, 5, 6, 7 and 8, the fee simple in all real estate, subject to bequests contained in item eleven.

Paragraph thirteen names the son, Martin, as executrix, and he qualified today as such.
