Democratic Leader Garrett gave notice that he would endeavor to have passed the motion instructing the house conferees to insist on broadening the Borah proposal. Republican Leader Mondell also announced to the house that he believes the majority of the republicans favored its extension.

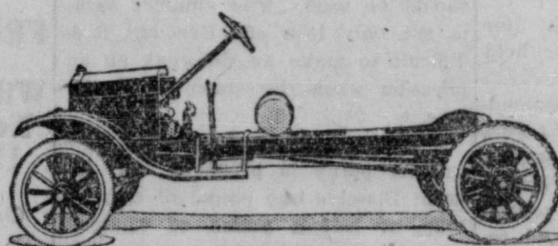
