Asking for Rehearing in Liquor Law Case

Indianapolis, May 4.—A rehearing of the Crabb's liquor case in which the supreme court recently decided that possession of liquor was not a violation of the state prohibition law is asked in a petition filed with the clerk of the supreme court today by Attorney-General U. S. Lesh and Mrs. Edward Franklin White, deputy attorney-general.

Oral arguments on the petition were asked by the state officials, which is an unusual procedure in such cases. The court has not acted on the petition.

"Oppellee (the state of Indiana) respectfully petitions the court for cause," said the petition. "In view of oral arguments in the above entitled the great importance of the decision rendered in this cause to the enforcement of prohibition it is respectfully urged that opportunity may be given in the Fred Kohler liquor case rehearing at an early date."

The Crabb's case decision which in

validated sections of Indiana prohibition laws making possession of intoxicating liquor a felony has resulted in making conviction of persons charged with liquor law violations "a little more difficult," according to officials.

Financial papers valued at \$2,500 were stolen Wednesday night from the American Railway Express office in the Lake Erie & Western railroad station at Ossian.
