#### Five Killed At Crossing

(United Press Service)  
Terre Haute, Ind., July 12—(Spe-  
cial to Daily Democrat)—Although  
three survive, only two persons were  
able today to tell the story of a  
crossing tragedy which took the  
lives of five people near here last  
night. The third survivor is a 13-  
month-old baby who escaped with a  
few slight bruises.

The dead are: Mr. and Mrs. Ed  
ward Ellis of near Elkhartdale, a  
mining community; their niece, Lilly  
Ellis, 15, of West Terre Haute, and  
Ernestine and Margaret Dunlap, age  
7 and 12, respectively, daughters of  
Mrs. Fred Sterchi.

Mrs. Sterchi was seriously injured,  
as was another of her daughters,  
Dorothy Dunlap, aged 10. Both will  
recover.

A Ford car in which the eight were  
riding was struck by Big Four West  
bound train No. 19, at Coal Bluff.
