### Leonold-Loeb Lawyers Split Fee Of \$130,000

 Chicago, Jan. 9.—The three lawyers who so successfully defended Nathan Leopold and Richard Loeb, millionaires, who confessed to murdering Bobby Franks, school boy, have split \$130,000 it was made known today. This sum has been approved by the Chicago Bar association.  
 Clarence Darrow, chief defense attorney, has received approximately

half of that sum, it was intimated, although all of the parties involved refused to divulge the division of the fee.

Attorneys Benjamin and Walter Bachrach, who aided Darrow, have split the balance of the sum, it was believed. It was indicated that the attorneys had asked \$200,000 of the Leopold-Loeb families, but that this proposal was rejected.

Estimates of the cost of the trial to the two families, including attorney fees, expert alienists and other items, place the total at \$250,000. The cost of defending Bernard Grant, penniless "back of the yards" youth, under sentence of death for a murder to which he pleads not guilty total little more than \$500 to date, it was estimated.

### New State Hospital For Women Is Gift To I. U.

Bloomington, Ind., Jan. 9.—A new \$250,000 state hospital for women to be located at Indianapolis, the gift of Mr. and Mrs. William M. Coleman of Indianapolis, to the Indiana university school of medicine, was announced here today by trustees of the university. This is the second large contribution of Mr. and Mrs. Coleman to the I. U. School of Medicine within the past six months. Last June they endowed three chairs in the school with a gift of \$75,000. They also subscribed \$25,000 to the James W. Lomb Riley hospital for children about a year ago. Their gifts to the school of medicine are as a memorial to Mrs. Suemna Coleman Atkins, daughter of Mr. and Mrs. Coleman.

Mr. Coleman's attorney, William L. Taylor, of Indianapolis, represented the donors in the transaction, and Dr. S. E. Smith, provost of Indiana

university, represented the institution.

"This very generous gift of Mr. and Mrs. Coleman assures the hospital immediately upon the passage of a bill by the legislature authorizing the acceptance of the gift and providing for its maintenance," said J. W. Foster, president of the board of trustees of the university.

"That Indiana university should be this last and greatest gift of Mr. and Mrs. Coleman is most gratifying. Present hospital accommodations for women in our state who are unable to pay for necessary medical and surgical attention are wholly inadequate," was Mr. Foster's comment. "Of scarcely less importance to the people of the state is the fact that this hospital, in accordance with the desire of the donors, will contribute much to the training of physicians and nurses who will find here opportunities for study as good as may be found anywhere. Needless to add, that the trustees of the university will conscientiously endeavor to administer this fund and to carry out faithfully the splendid purposes of Mr. and Mrs. Coleman."

In making the gift, Mr. Coleman had the following to say:

"Mrs. Coleman and I have given to the Indiana University School of medicine at Indianapolis the sum of \$250,000 to be used in building a women's hospital to be used principally for lying-in patients and a smaller part for those who need the expert attention of surgeons and physicians, and where those who are unable to pay can have the same high order of attention as those who are able to pay part or full price for such services. We entrust this work to the trustees of Indiana University, knowing it to be a non-partisan institution governed by men whose aim in life is to

work for the good of mankind and whose work will go on as long as the state of Indiana is in existence.
