Central Normal Plans Invitational Track Meet

Danville, Ind., Mar. 31.—(United Press.)—Invitations to enter a team in the proposed track meet here May 5 have been sent out today to a number of college in Indiana by Russell Cook, director of athletics at Central Normal college here.

The proposed meet here is to be open to colleges which have not been strong in track and field athletics in recent years.

Those colleges to which invitations have been sent are Evansville college, Oakland City, Manchester, Huntington, Indiana Central, Muncie Normal, Franklin, Hanover, Rose Poly, and the North American Gymnastic college.

The meet is to stimulate interest in the cinder path in the state.

To Build New Gym At Indiana State Normal

Terre Haute, Ind., Mar. 31.—(United Press.)—Plans are being drawn here for the new gymnasium at the Indiana State normal.

The gymnasium will cost \$75,000.

The site for the building is to be chosen soon. It is to be donated by citizens.

The money for the building was appropriated by the 1925 legislature and was one of the chief grounds of contention in the enactment of the general appropriation bill.

An appropriation for \$110,000 for the building was asked in an amendment as it was originally attached to the bill but a compromise was reached on \$75,000.

In view of the fact that the full amount was not appropriated the building will be built so that additions can be made later.

Suit For Accounting

A suit for an accounting was filed in the circuit court today by George Myers against Wayne Bebout. Doctor On Stand Again

Dr. John Gilpin, secretary of the Fort Wayne board of health, was on the witness stand all day again today in the trial of the damage suit against the Pennsylvania Railroad company and the City of Fort Wayne, resulting from the typhoid fever epidemic in that city in the fall of 1923. Much time was lost this morning while the law was investigating regarding the submission of evidence in the case. More than one hundred items in the records of the board of health have been introduced as evidence so far. Thirteen witnesses have testified in the trial so far, and it is said that the plaintiff will call many more before it rests its case.

Bluffton.—Following rumors that a new grave had been dug near the place of the recently attempted suicide of Orel Schwartz on the John Schwartz farm near Vera Cruz, and believing that it might be the grave of Orel Schwartz, his brother who disappeared a year ago, Wells county officials made a thorough investigation.

It was discovered, however, that the place where the grave was said to be was only a sink in a newly constructed drain. Another place examined on the Schwartz property was the newly dug grave of a colt. The investigation was dropped.

Large Factory Needs Young Men During Summer

M. J. Mylott, superintendent of the Decatur Light and Power company, is in receipt of a letter from the employment department of the American Rolling Mill Company, Middletown, Ohio, which states that, in all probability, that company will need the services of several young men for work in their factory this summer.

The employment system of the company, the letter states, is such that all promotions are made from persons already employed by them. It further says that, due to heavier amount of work during the summer months, it is always necessary for them to employ young men, of school age, during vacation time. More information as to wages and time of employment will be forwarded to Mr. Mylott at a later date.

Mr. Mylott wishes to get in touch later with several young men who want to work this summer, and it is highly probable that the American Rolling Mill company will take care of them, he said.

State Ready To Entertain Larger Number Of Tourists

Indianapolis, March 30.—(United Press.)—Indiana was prepared today to entertain an increased number of tourists, the state department of conservation announced.

Tourists last year spent approximately \$20,000,000 in the state, according to Richard Lieber, director

of the department. The chief centers of attraction were the chain of the state parks and the eight transcontinental highways which cross the state.

Hundreds of thousands of motorists use these highways annually, Lieber said.

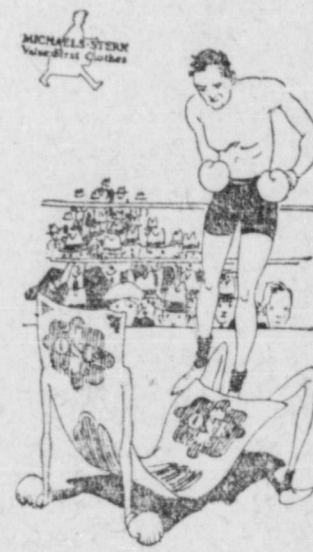
