The Mellon plan, endorsed by President Coolidge, is to reduce the income tax, especially for the very rich. The tariff and other indirect taxes are not to be touched except as the present tariff commission will raise rates upward. For a time it looked as if the common people would swallow this program. But first President Green of the A. F. of L. threw a bomb by asking some rude questions as to why the high tariff textile industry should be reducing wages. Should the tariff on woollens be kept at its present high point? Then on the heels of President Green's statement the Automobile Association points out that the tax on the automobile parts falls hardest not on the rich, but on the farmers, to whom the automobile is a necessity and rough use inevitable. It ought to be repealed before the super tax on big incomes

State Officials Dislike Salary Cutting Tactics

Indianapolis, Oct. 22—There is much grumbling going on in the corridors and offices of the state house these days.

The grumbling is a direct result of the action of the state budget committee in slashing salaries and eliminating a number of state offices.

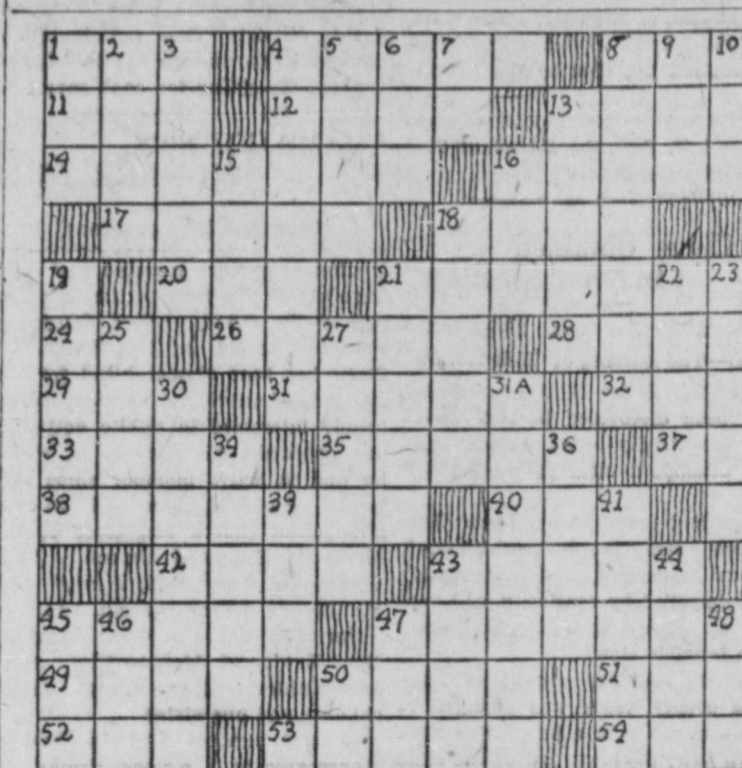
Alfred Hogston, state fire marshal refused to issue a statement on the changes which hit his department especially hard. He said that he would have something to say as soon as he had been officially notified by members of the budget committee of the changes.

The budget committee abolished the office of Fred T. King, attorney in charge of the prosecution of arson cases in the fire marshal's department. He declares there is "serious objection" to abolishing the office of the attorney for the fish and game division, but that "there is nothing I can do but sit tight and await consequences."

"The result of the committee's action will show itself later on," he said.

Will Consider Action Against Players-Writers

New York, Oct. 22.—(United Press).—Action against players-writers and a proposal to close the regular playing season earlier will be considered by the major league club owners at their annual meeting in December.

After the umpires had complained during the world's series about criticism appearing in articles under the names of Bill McKechnie, Muddy Ruel

and Roger Peckinpaugh, Commissioner Landis expressed himself as being opposed to the literary activities of players and promised to give the subject serious attention.

The commissioner is expected to have some remedy ready to propose to the club owners of the two major leagues at their next meeting.

The club owners, feeling that the player-writer question is one directly in the hands of the commissioner, are not much interested in it, but they are interested seriously in the subject that has been made to close the season earlier and avoid the weather gamble in the world series. It has been suggested that the championship be ended late in September and that the first game of the world's series be played on October 1.

The Baseball Writers' association also will take up the player-writer question as it concerns the members of the association.

Ina Claire, Noted Actress, Gets Divorce

Chicago, Oct. 22.—(United Press).—Ina Claire, noted actress and one of the most beautiful women on the stage, has gained her freedom from James Whittaker, critic and former newspaperman of Chicago. Judge John E. Caverly late yesterday granted the actress a divorce on the grounds of cruelty.

Miss Claire married Whittaker in Wheaton, Ill., six years ago because he was "such an interesting character." In 1923, Miss Claire lost interest when, according to her story, Whittaker threw her out of their New York apartment. Previous to that during a stay at Tomahawk Lake, Wis., Whittaker gave her a beating, the actress testified.

The actress did not ask for alimony.
