Bob McDonough Wins Laurel Speedway Race

Laurel Speedway, Laurel, Md., Oct. 27.—Bob McDonough, the young Irish automobile racer, won the 250-mile race and \$25,000 purse Monday. He failed to break the world's record for distance by only a few moments. His unofficial time was 125.7 miles an hour.

Close behind in the order named Peter De Paola, Tommy Milton and Ralph Hepburn. Of the 16 entrants De Paola, Milton and McDonough were considered the class with much money being wagered on the Italian.

McDonough's time for the completed course was 1 hour, 59 minutes and 27 seconds. Tommy Milton's time was 2 hours, 1 minute and 45 seconds. Fred Wagner, the starter, said the winner's time was little slower than Milton's when he established the world's record at Culver City.

The race, originally scheduled for Saturday but postponed because of rain, was held over a pine board track now as dry as a chip from winds that followed the rains.

Race positions were drawn by lot. No trials were held.

the state of affairs of French finances arising from the failure of the French internal loan to come to expectations and from the fear of new inflation in any measures Caillaux could present. He had been accused in some quarters of failing to take sufficiently strong measures to cope with a situation requiring drastic remedies. And he was opposed to a capital levy as desired by the group upon which the government relied in parliament for its support.

Secondly, there was much displeas-

ure with Caillaux for failing to achieve at Washington settlement of France's debt to America, although Sunday Caillaux suggested that it would not be many months before a real agreement would be forthcoming.

Babe Ruth Tells How He Squandered His Money

New York, Oct. 27.—Babe Ruth, reckoning his financial losses, in an interview in Collier's Weekly, says gambling cost him \$125,000; business reverses \$100,000; lawyers and detectives \$25,000. But he said he has paid up an endowment policy that will pay him \$500 a month when he is 45 years of age.

Wills' Two-Minute Win Over Johnson Questioned

New York, Oct. 27.—Official investigation by New Jersey boxing authorities is expected to be made into the two-minute victory which Harry Wills, negro heavyweight challenger, scored over Floyd Johnson, Iowa heavyweight, last night in Newark. Ten thousand fans who packed the big armory roared in protest and derision when a towel came sailing in from Johnson's corner before the contest had a good start.

Wills following his usual style of holding with his long left arm and pounding the body at close quarters with his right had backed Johnson into his corner and was plastering him with body punches when Charley Cook, Johnson's manager and chief second, tossed the towel in the ring.

Johnson was on his feet at the time and looked to be in no immediate danger and he was almost as surprised and as stunned as the crowd when the referee told him he was

through for the evening. He made a protest that he wanted to continue but it was only a gesture and he seemed perfectly content when he left the ring.


