Restrict Issuance Of Sacramental Wines

Washington, Nov. 13—(United Press)—New treasury regulations restricting the issuance of sacramental wines to less than one million gallons annually have been drafted by Assistant Secretary of the Treasury Andrews, prohibition czar, and will be sent out to enforcement officers this month.

Detection of a dozen different schemes of obtaining "sacramental wine" fraudulently led to the drafting of the new regulations.

Noblesville, Ind., Nov. 13.—(United Press)—Biting accusations were hurled thick and fast today in closing arguments in the murder trial of D. C. Stephenson, former Klan dragon, Earl Klenck and Earl Gentry, for the death of Madge Oberholtzer.

Charles E. Cox, assistant prosecutor, described the trio of defendants as "gorilla men" and asked death for them.

Cox flogged Stephenson mercilessly, describing him as a "moral degenerate and beast and a despoiler of women's virtue."

Ira Holmes, defense attorney, countered with the charge that Stephenson was being persecuted to wrest from him the last of his political power.

Ten more hours of closing argument remained when court opened today. The state has four hours remaining and the defense six.

The case is expected to go to the jury before noon Saturday.

The state, Holmes declared, had failed to present any evidence on which to base a conviction for murder.

He insisted the death of Miss Oberholtzer was suicide and nothing more, and laid her plight to her own doors. If she had not been a willing member of the party which ended in her death, there would have been ample opportunity for her to call for help, he argued.

Miss Oberholtzer's dying statement was drawn by a lawyer for the purpose of extracting money from Stephenson, Holmes charged.

Prosecutor Remy in opening the state's argument, outlined and weighed the evidence in the case, stressing testimony that supported the dying declaration.

Hoosier Truck Company Threatens To Boycott Ohio Accessories Firms

Columbus, O., Nov. 13—The fight between the states of Indiana and Ohio over conflicting motor bus regulation took a new turn today.

The Ohio public utilities commission received a letter from an Ohio firm enclosing a circular letter from the Red Ball Transit company of Indianapolis threatening to boycott Ohio firms unless the Ohio commission ceases its enforcement of truck laws through the arrest of Indiana men who operate in this state without permits.

The Red Ball threatens to extend its boycott to all Ohio firms dealing in motor accessories and claims to have some allies in its proposal.

Members of the Indiana public service commission conferred with the Ohio officials early this week on the matter and went away apparently satisfied after studying the Ohio law.

The Ohio commission will take no notice of the boycott threat.

W. C. T. U. Meets In Annual Convention

Detroit, Mich., Nov. 13—Dedicated to a vigorous national campaign for law enforcement, more than 2,000 members of the National Women's Christian Temperance union met here today for their 51st annual convention.
