New York, Nov. 4.—(United Press.)—Riflemen, special guards armed with riot guns and machine guns were ordered on duty at all prisons here today to prevent a repetition of the murderous outbreak in the Tombs yesterday in which four men were killed and three wounded.

A feeling of unrest prevails among the thousands of criminals, authorities believe, and they have been afraid for weeks that a wholesale outbreak would be attempted.

It came suddenly yesterday and the Tombs guards were caught unaware. Three notorious criminals tried to shoot their way out and almost succeeded.
