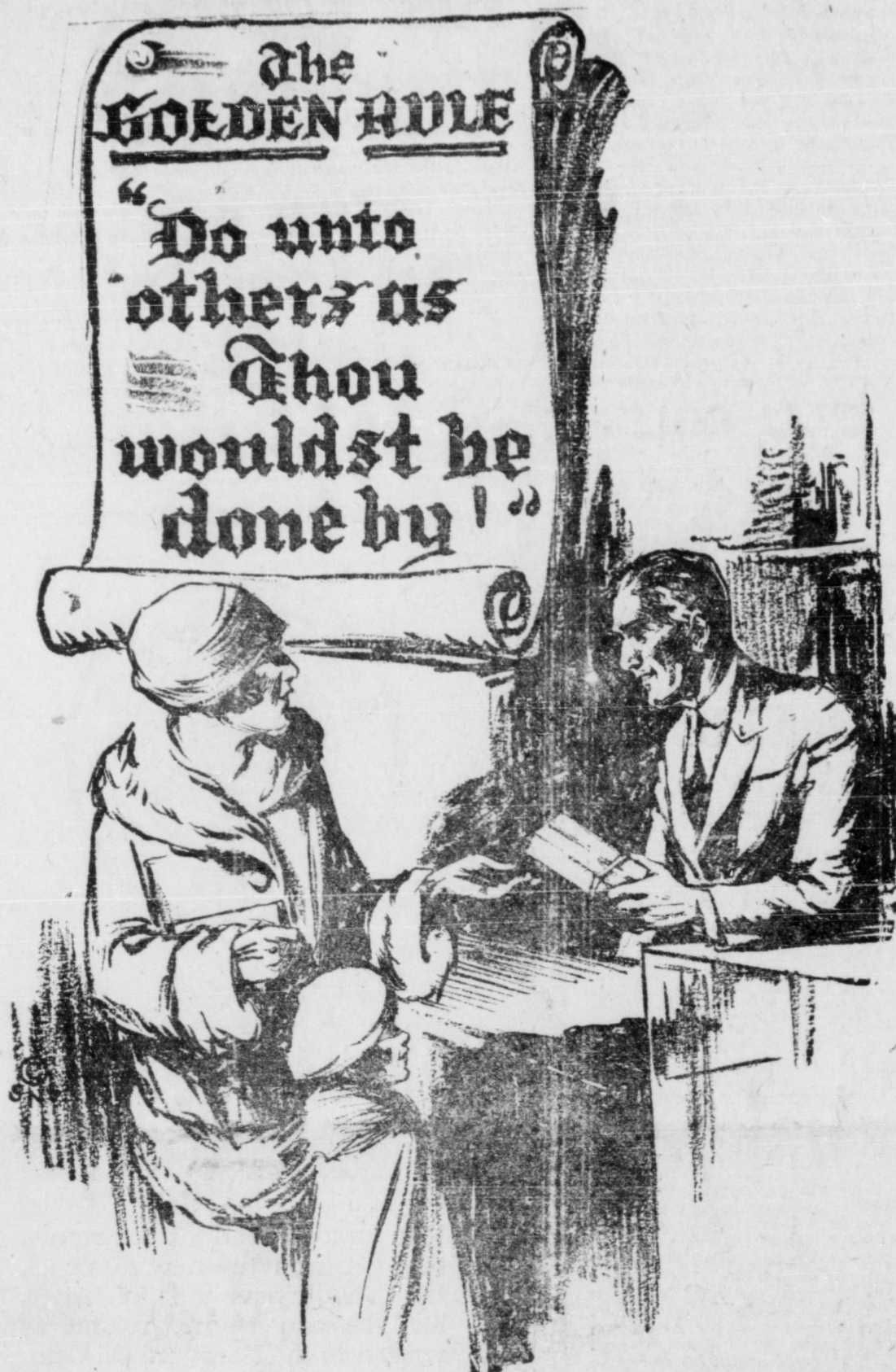


"As Thou Wouldst be Done By"
