MAIN SEWER IMPROVEMENT
RESOLUTION
No. 1—1927

RESOLVED, by the Board of Trustees of the Town of Berne, in the State of Indiana, that the construction of a main sewer intended and adapted only for use by owners of abutting property along the line thereof, but also intended and adapted for receiving sewage from collateral drains already constructed, of which may be constructed in the future, and the same is hereby ordered in and along Water Street with appurtenances and branches as follows:

Commencing on the north line of Bryan Street in the alley between Lehman St. and Indiana Ave; thence north along said alley to the approximate center line of Water Street; thence east along the center line of Water Street to the Eastland Corporation line and extending easterly along said center line of Water Street. Extended to a point approximately 600 feet and terminating in an open ditch and the following appurtenances and branches to be known as "Compromised Street" commencing at the intersection of Compromised Street and the west line of Logan Street; thence easterly along the south side of Compromised Street to the center of Welty Street; thence south along the south line of Welty Street to the south side of Bryan Street; thence southeast across the northeast corner of land owned by the Homer Manufacturing Company to Jackson Street; thence southeast to center line of Jackson Street south to a point approximately 200 feet north of lot number 331, original plat; thence southeast across land owned by P.
