We want to lift ourselves away from it all. With the Psalmist of old we cry and plead, "Lead me to the Rock that is Higher than I." In the spirit of the writer we say:

"Lord, lift me up and let me stand, By faith, on Heaven's table-land. A higher plane than I have found; Lord, plant my feet on higher ground."

When such seasons come upon us it is then that we come into a consciousness of our real need. It is then that we begin to realize our helplessness and God's fullness. "But though He cause grief, yet will He have compassion according to the multitude of His mercies." Like a rushing tide that comes sweeping in and takes everything that is in its path—and yet the tide again recedes—so the sorrows of life come and yet they recede when we step to the Rock that is higher than we.

I love to think of that beautiful painting of the roaring and searing ocean but amidst the dashing of waves stands the cross to which the young maiden clings with the message:

"Rock of Ages, cleft for me, Let me hide myself in Thee."

"Lead me to the Rock that is higher than I." Yes, that is a step toward something more durable, something permanent—with stability—that which is spiritual and eternal. 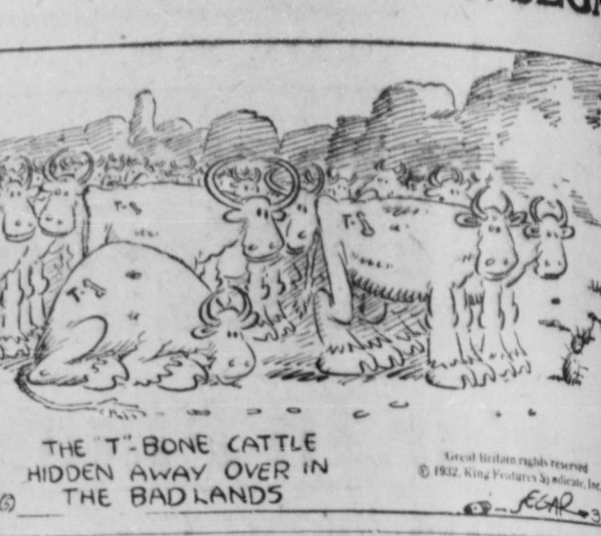
