Law Not Effective  
Until Next YearIndianapolis, Sept. 30—(UP)—The  
new Indiana law making appointment  
of county school attendance  
officers optional will not be effective  
until next year, Attorney General  
James M. Ogden has ruled.In an opinion given to Miss  
Blanche Merry, state school atten-  
dance officer, Ogden set out that  
the law, passed by the special ses-  
sion of the legislature, contained no  
emergency clause and present offi-  
cials took their positions August 1.There was no law in effect on  
the first of August that made ap-
