con. Vincennes, Evansville, New Albany, Jeffersonville, Madison, Connorsville, and Richmond.

Meanwhile, distribution of agreement blanks was continued by postmasters throughout the state and many codes of fair competition placed into effect.

At South Bend, the Studebaker plant began operation this morning with reduced hours and increased wages, affecting approximately 6,500 employees.

Plant workers were given a 15 per cent wage increase and salaried office workers received a 10 per cent raise. The change placed the minimum factory wage at 40 cents an hour for men and 35 cents an hour for boys and women. Factory workers will be employed not more than 35 hours a week and office workers were limited to 40 hours a week.

In addition to the Studebaker action, other South Bend employers announced nearly 1,000 workers had been added to their payrolls.

Codes of three state organizations were under discussion here today. Groups conferring were the Associated Theater Owners of Indiana, the Indiana Florists Association and the Indiana Automobile Dealers Association.

The Indiana Hotel Association and the Indiana Bottlers' association have meetings scheduled here tomorrow.

Stores in Elkhart will remain closed Saturday night, for the first time in history. A blanket agreement providing a six-day week was

adopted by 200 merchants in the Elkhart hotel.

Hailing the recovery program as "The Golden Opportunity of Labor," Union organizers addressed approximately 8,000 workers at Indianapolis last night.

Speakers on the program, among them representatives of the Central Labor Union and the American Federation of Labor, called attention to the clause in the National Industry Act allowing unmoled collective bargaining and urged organization of Unions before expiration of the law two years hence.

some semblance of order out of the chaotic oil industry was registered in a new code drafted by NRA officials and representatives of the industry. The new code proposes a work-week of 36 hours in the oil fields generally and a 40-hour week in the marketing end of the industry. These new proposals, drafted in Sweeting Hotel and conference rooms, will be the subject of new discussions before submission of the code in final form for President Roosevelt's approval.

The blanket code was modified for retail stores to enable most of the nation's retailers to come under the recovery act immediately. Many had complained that the original terms would work too great a hardship. The thousands of retailers who already had signed the original agreement are permitted to change it now in accordance with the new schedule of hours and wages. The modifica-

tion, however, is subject to later action on the permanent retail codes. Hearings began August 15.

Food and grocery distributors are permitted to work under a 48-hour week, instead of the 40-hour week in the general agreement. The 1,000,000 clerks in such stores have been working up to 73 hours a week.

The other division of the retail industry—dry goods, department, specialty, mail order, men's clothing and furnishing, furniture, hardware and shoe stores—will have a 40-hour week.
