NEW MAYOR IN
UTILITY FIGHT

Mayor Bangs of Hunting-
ton Opens Fight For
Municipal Plant

Huntington, Ind., Jan. 2.—(U.P.)—Three Huntington homes burned electricity from the city's power plant in defiance of a circuit court order today while Mayor C. W. H. Bangs, inaugurated yesterday, promised to go to jail if necessary to win the city's fight against the Northern Indiana Power Company. The mayor, an attorney and newspaper editor, was elected on a platform promising a municipal power plant. One hour after he was inaugurated he obtained an ordinance from his city council authorizing initiation of service from a tiny existing plant. While attorneys for the Northern Indiana Power Company hurriedly obtained a restraining order from a circuit court, Bangs supervised connection of three homes to the city plant. When the court order was served, compelling continuance of the status quo pending further hearings, the connections were accomplished. Bangs appointed J. H. Adkins, formerly of Washington, Ind., superintendent of the plant and said "we're going to have a light plant, if I have to go to jail."
