Estate Case

Motion Overruled
A motion for a new trial was overruled in the divorce action brought by Grace M. Ruffner against Karl Ruffner and venue here from Wells county. The defendant excepted. One hundred and 20 days were given to file all bills of exceptions. An appeal to the appellate court was asked. The appeal was granted and 60 days time given to file bond. The appeal bond was fixed at \$300.

SEN. DICKINSON RUNNING AHEAD

Iowa Republican Running Nearly Two To One Over Opponent

Des Moines, Ia., June 2.—(U.P.)—United States Senator L. J. Dickinson, bitter foe of new deal farm policies and mentioned as a Republican presidential candidate, appeared to have won renomination today.

Dickinson based his campaign daily on his opposition to the new deal. He was the particular target of Democrats urging retention of new deal farm policies.

Incomplete returns from yesterday's primaries gave Dickinson almost a 2-to-1 lead over his closest rival, former Sen. Smith W. Brookhart.
