New York, Nov. 5.—(UP)—Radio corporation of America's declaration of a 20-cent a share dividend on common stock, the first in its history, stimulated the stock market today.

Prices throughout the list advanced fractions to more than 2 points. Gold issues were prominent on the upside and homestead mining made a new high at 53 up 3 1-3 points. Steels showed gains ranging to more than 2 points in Bethlehem. Radio crossed 8 for a gain of nearly a point.
