

## Former Vera Cruz Resident Is Dead

Final rites will be conducted Sunday at 1 p. m. at the Apostolic Christian church near Vera Cruz for John Myer, 85, who died Wednesday in Gridley, Ill.

Mr. Myer had been in ill health for the past four years and had been critically ill the past two days. He died about 11:45 a. m. Wednesday at the home of his daughter, Anna, in Gridley. A former resident of Vera Cruz, he was born February 26, 1874, in Hamburg, Germany. He and Mary Rudin were married March 2, 1900, in Cissna Park, Ill. She died Oc-

tober 23, 1955. Mr. Myer had resided in Gridley for the past eight years. He was a member of the Apostolic Christian church. The body will be brought to the Goodwin funeral home in Bluffton after services at 10 a. m. Friday in Gridley. Friends may call at the Bluffton funeral home after noon Saturday. The body will be taken to the church at 12:30 Sun-

day afternoon to lie in state until the services, with the Rev. Samuel Aeschliman officiating. Burial will be in the church cemetery. Surviving are four daughters, Miss Anna Meyer, Gridley; Mrs. Ray Gerber, Bluffton; Mrs. Mark Wright, Zanesville, and Miss Margaret Meyer, Bluffton; two sons, Joe Meyer, Bluffton, and Amos Meyer, Gridley; six grandchildren

and three great-grandchildren; and one brother, Henry Meyer, Mononk, Ill. A daughter and a sister preceded him in death.
