Claims For Gas Tax Refund To Be Filed

Annual claims for refund of federal excise tax paid on gasoline used for farming must be filed by September 30. Sterling M. Dietrich, district director of Internal revenue, said these claims should be made on form 2240 for gasoline used between July 1, 1958 and June 30, 1959.

Dietrich said copies of form 2240 and a helpful booklet, "Farmer's Gas Tax Refund," Publication No. 308 (6-58) can be obtained from internal revenue offices at Fort Wayne.

Suffers Broken Neck In Diving Accident

Eugene Newcomer, 17, a senior at Geneva high school where he was active in basketball, baseball and track, suffered a broken neck Monday while swimming at Pine Lake near Berne. Newcomer is a patient at the Adams county memorial hospital under the care of a Geneva physician. X-rays disclosed that the injury was definitely a broken neck.

Newcomer is not recovering, however, and a full recovery is hoped for. The accident happened when Newcomer dived from the raft at Pine Lake just as Larry Foreman, a senior at Adams Central, came to the surface. Newcomer's head struck Foreman on the shoulder very hard, and Newcomer was knocked unconscious. Foreman carried him to shallow water where lifeguard Ned Bixler took over until the arrival of an ambulance.

Third Housing Bill Approved By House Today

WASHINGTON (UPI) — The House by voice vote gave final congressional approval today to a "third try" housing bill which congressmen said President Eisenhower would sign into law.

The third catch-all housing bill of this session — a billion-dollar measure — passed the Senate, 86-7, Wednesday.

Today's House action sent the bill to the White House, ringing down the curtain on a year-long struggle between the Democratic controlled Congress and Eisenhower over the shape of housing legislation.

Eisenhower vetoed the first two bills which Congress presented to him, contending they were extravagant. Democrats finally made concessions in the third bill and gained assurances he would sign it.

The House finished work on the bill by passing it by voice vote after only a few minutes of debate, shortly after the House had voted to override Eisenhower's second public works appropriation veto.

Eisenhower vetoed as extravagant the first housing bill. Congress sent him on June 23. He gave the same reason for vetoing the second which reached him on Aug. 27. The Senate upheld both vetoes.

Democrats had advance assurances that the President would sign the third measure even though it still retained some provisions such as public housing that he opposed in his veto messages.

In working out the compromise, Democrats made three major concessions to the administration.

They eliminated a proposed program of college classroom loans, agreed to a stretch-out in spending on the urban renewal program and eliminated an Oct. 1, 1960 cutoff date for new mortgage-insuring authority for the Federal Housing Administration.

Plane Carrying Four Is Reported Missing

LAFAYETTE, Ind. (UPI) — A single-engine private plane carrying four passengers has not been heard from since it took off from Purdue University airport Wednesday night, authorities said today.

The pilot of the plane was tentatively identified as B. Hanebrink of Quebec, Canada. Names of the three passengers were not available immediately.

Airport officials said the pilot filed a flight plan to Lambert Field in St. Louis, Mo. A check with St. Louis this morning revealed that the plane had not landed there, authorities said.

equipment. The custodian lost a requested raise of \$180 in the cut. The budget was left then at \$11,120 from a requested \$11,750.

Jail Cut

The county jail budget was cut \$300 to \$4,480 with the cut coming in the repair of building request. The county home lost \$700 as \$300 went from the salary of the superintendent, \$300 in wages to other employees, and \$100 for cloverseed and feed corn. The budget is now \$27,660.


The county commissioners requested \$55,900 but received \$31,295 as \$200 was sliced from each of the township's deputy assessors for per diem.

The county highway department, which receives its income from gasoline taxes was cut from a requested \$379,775 to \$369,625 as men, truck and tractors request, \$6,000 was lopped from the repair to trucks and machinery, \$1,000 from diesel fuel, and \$1,000 from miscellaneous, plus \$150 from the clerk's \$300 requested raise.
