

Critically Injured In Fall From Window

FORT WAYNE, Ind. (UPI)—Mary Hickie, 31, Fort Wayne, was injured critically Wednesday when she apparently fell from a window of her second floor apartment. City police held John Rose, 21, under \$2,000 bond on vagrancy charges as a material witness. Officers said Rose was in the apartment at the time.

First Bedford Traffic Death in Three Years

BEDFORD, Ind. (UPI)—William Woods, 5, Bedford, became this city's first traffic fatality in three years when he died at a hospital in Indianapolis Wednesday night. The boy suffered head injuries earlier in the day when he apparently walked into the path of a car driven by Bernard Lee Bush, Springville, authorities said.

Kennedy Attends Union Convention

CHICAGO (UPI)—Sen. John F. Kennedy today followed Adlai E. Stevenson before a union convention that has endorsed the Massachusetts Democratic for his party's 1960 presidential nomination.

Kennedy flew here from a West Coast campaign jaunt to address the 220,000-member Textile Workers Union of America.

The union's convention Tuesday praised Kennedy as a "down-to-earth, yet far-seeing liberal who can give our nation the dedicated leadership these critical times demand."

Stevenson recognized the Kennedy endorsement Wednesday when he was given a whistling-table-thumping welcome by the textile workers.

He told the union members that by their action on Kennedy's candidacy "you have... expressed your continued support for liberal, Democratic principles."

William Pollock, general president of the TWUA, said Stevenson—who has said repeatedly he is not seeking a third presidential nomination—that "organized labor is looking for a liberal candidate and if one is nominated we will elect him."

In his speech, Stevenson once again attacked the Eisenhower administration's handling of the U-2 plane incident and charged its "effectiveness for leadership... has been impaired if not destroyed."

Stevenson said Vice President Richard M. Nixon and other Republicans "would like to hush all discussion of foreign policy."

"With a national campaign coming up, I hope we can talk sensibly and that every criticism and proposal won't bring forth cries of 'appeasement' and 'soft on Communism,'" Stevenson said.

Deposed Turk Leaders Face Early Trials

ANKARA, Turkey (UPI)—The ruling National Unity Committee announced today that leaders of the deposed Menderes regime will go on trial within a month, and that elections for a new parliament will be held in the shortest possible time.

Observers here speculated that the elections would not take place until the trials of ex-Premier Adnan Menderes and other deposed leaders have been completed—perhaps several months from now.

The discovery here and in Istanbul of the graves of a number of young Turks believed to have been killed by police during anti-Menderes riots increased speculation that the ex-premier and some of his aides might face the death penalty.

There were reports as many as 70 bodies had been found—some of them in refrigerator boxes—but the new government of Gen. Cemal Gursel declined to disclose the exact figure.

It was becoming more clear by the hour that the 20-man military junta headed by Gursel—termed the "Committee of National Unity"—was emerging as the real power in the nation.

Col. Ertugrul Alati, spokesman for the committee, said Wednesday the army had arrested the more than 400 members of Parliament who belonged to Menderes' Democratic Party.

He said they were being transferred to the island of Yassiada in the Sea of Marmara to be held pending an investigation to determine whether they should be charged with violating the Turkish constitution.

If the investigating committee places such charges and a court convicts them, "it could mean even death," Alati said.

Milkman's Wife Is Held In Shootings

VEVAY, Ind. (UPI)—A milkman's wife was held for questioning today in the wounding of her husband and the gun death of a woman in whose home she found him visiting.

Mrs. Erma Jean Park, 30, admitted to Sheriff Albert D. Rosenberger that she fired shots from a pistol which killed Mrs. Dorothy Scott, 30, and wounded her husband, Robert Park, 33, so critically he may die.

Rosenberger said Mrs. Park telephoned his office late Wednesday and told him to hurry to Mrs. Scott's home.

"I just shot my husband," Rosenberger quoted her as saying.

When the sheriff arrived, he found Mrs. Scott dying in a pool of blood in the living room of her home on a knoll a mile north of Vevay, and Park lying on the kitchen floor with a bullet in his abdomen.

Park was rushed to Kings Daughters Hospital at Madison where doctors said he was in extremely critical condition.

Mrs. Park, shaken and in a state of shock, was unable to give authorities a coherent account of the shooting. She was held in Switzerland County Jail on open charges pending further questioning.

Park was an independent bulk milk hauler. His truck was parked in the driveway of the Scott home.

Mrs. Park was an employee of a Vevay industrial plant. Mrs. Scott's husband, Harlan, about 30, also worked at the same plant.

Mrs. Park has three children.

Mrs. Scott was the mother of four and her children were playing in the yard when the shootings occurred.

Food Formulas For Overweight Adults

NEW YORK (UPI)—Food formulas for overweight adults, designed to appease hunger while bringing the individual steadily downward in girth and weight, are now for the first time available in New York and certain cities of the Eastern Seaboard.

The formulas, each in form of a powder to be added to water and substituted for meals, are described as nutritionally adequate, pleasantly tasting and encouragingly prompt in effectiveness.

Release of the formula foods, several of them made by pharmaceutical companies and one by a food company, followed closely upon publication by the Society of Actuaries of findings indicating that the "ideal weight" tables of the life insurance companies are from 20 to 30 pounds below the national average.

The charts heretofore used were in fact on an average considerably too liberal, according to *Changing Times*, the Kiplinger magazine.

The records of five million persons to whose estates life insurance payments had been made over a quarter of a century, were studied by the actuaries.

Death rates of average, fat and slim persons were compared. Here are the results, as summarized in an article entitled "Weight Average? Start Dieting!" in the magazine section of the New York World-Telegram and Sun:

For men 20 pounds above the national average (this would include many who felt themselves to be of exactly average weight for height and age under previous life insurance company recommendations), the death rate was 10 per cent above average.

With 25 pounds overweight, the death rate suddenly increased to 25 per cent above the national average.

With men 50 pounds overweight the death rate was 75 per cent above average.

This report, adopted by the Metropolitan and other life insurance companies, asserts that the best weight is approximately 20 pounds below the national average.

Eisenhower Proclaims June 14 As Flag Day

Johnson Pleased With Western Tour

WASHINGTON (UPI)—Senate Democratic Leader Lyndon B. Johnson is out of the presidential starting gate and running with the sure-footedness of a Texas quarter horse.

But after a six-state Western campaign swing Johnson still is withholding an announcement of his candidacy.

There is at least a good chance he will say nothing formally about being a candidate until just before the Democratic convention opens in Los Angeles on July 11—if then.

The Texas Democrat returned to the Senate late Wednesday, tired from his six-day Western trip but obviously pleased with what he found.

During his absence, his presidential hopes were given a lift by two developments.

One was a full-page advertisement carried in 18 major newspapers across the country, urging Johnson to "become an active candidate for the nomination."

The other was an editorial endorsement by the Scripps-Howard newspapers, whose 19 editors joined in calling him the "ablest and strongest Democrat available" for the presidency.

Johnson is known to feel that the delegate claims of the Democratic presidential "front-runner," Sen. John F. Kennedy (D-Mass.) are somewhat inflated.

Steers served as a PT boat commander in World War II and later served with the Navy Judge Advocate General's office.

Attorney General Seeks Renomination

INDIANAPOLIS (UPI)—Atty. Gen. Edwin K. Steers took himself out of the lieutenant governor race late Wednesday by announcing he would seek renomination as attorney general at the June 24 state GOP convention.

Steers had been mentioned as a Republican lieutenant governor possibility. At least four Republicans already have announced their intentions to seek that nomination.

"I have very seriously considered whether I should continue in public office," Steers told newsmen. "A number of county chairmen and delegates have urged that I do so in the best interests of the Republican party."

"To avoid further speculation as to my intentions with the state convention only a few weeks from now, I am announcing my candidacy for the office of attorney general," he said.

"I am proud of the record of my office and my deputies," Steers said. "I will run on that record."

Steers now is serving his second term as attorney general. He seemed assured of getting the renomination for his third term.

Steers first was elected in 1954

at the age of 39 and was one of the youngest men ever elected to the office. He was reelected in 1956.

He is the son of Edwin M.S. Steers, former treasurer of the GOP State Central Committee and now a Republican member of the State Election Board. The attorney general was a prosecutor for war criminals tried at Nuremberg.




