Tax Savings Total \$983,000 Here

There will be more spending money in Adams county soon and, consequently, more business activity as a result of the tax cut approved by congress. The first effects here will be felt the week of March 8-14.

The bill provides for tax reductions of different sizes, varying according to income level.

For those with modest incomes, the reduction in the tax rate is dramatic. Families in the lower brackets will profit considerably from the new "minimum standard deduction" of \$400 for husband and wife. Many families will be lopped off the tax rolls because of it.

Effect Here

In Adams county, where average earnings have been on the rise and have reached \$8,600 per household before taxes, the savings will be greater than in many other communities.

For a married couple locally with two dependents and with an income equal to the prevailing average, the tax on 1964 earnings will become \$1,010, or \$140 less than before.

For families with gross incomes at the \$12,000 level, the annual tax will drop to \$1,675, a cut of \$185.

Where gross earnings are only \$4,000 a year, the new tax will be \$220, which is \$68 below the current rate.

\$983,000 To Spend

Taking into account all Adams county's families, those with large incomes as well as those with small ones, the tax reduc-

tion based on present earnings will total approximately \$983,000.

The addition of that much cash to the amount already in circulation locally will have a multiple effect, according to the economists.

Their explanation, in brief, is that the increase in consumer buying will deplete store stocks, thus creating the need for more merchandise. This, in turn, will stimulate factory production, cause the hiring of more work-

ers and, finally, put more money in the hands of consumers.

Residents of Adams county will see the first tangible results of the tax cut shortly, when the amount deducted from their paychecks will be 14 per cent instead of 18 per cent.
