All homemakers are invited to attend the opening and closing of the three-day conference. Members of the Indiana Home Demonstration association will meet June 3 — association day — for their annual business meeting and election of 1965 officers.

Opening day will consist of consumer clinics covering these subjects:

Consumer problems of quality in clothing, public health, education beyond high school, foods and housing.

The evening program, June 2, will be a performance in the hall of music of the combined choruses of the Indiana Home Demonstration association.

Final day of the conference, June 4, will take up the rights of consumers.


