The first legal action by Muncie against the doubling of rates for natural gas by the two companies was taken when injunction proceedings were filed against the Heat, Light and Power company, asking for a temporary restraining order, pending the suit for a permanent injunction to protect the people from the new rates. The belief is current in some quarters that the city officials are not sincere in the action, for the reason that the customary bond for damages was not filed with the complaint, though an immediate restraining order is asked for. No action can be taken against the Muncie Natural Gas company, the major fuel supplier, until after the first of next month, when the new rates will be in force.
