BEAUTY ON ICE.—Saturday and Sabbath outside walks were coated with ice, much to the annoyance of pedestrians. We noticed quite a number of our fair friends "come down." It should be some consolation for them to know that the "wicked stand on slippery places."

A bill will, it is understood, be introduced in the Legislature, at an early day of the session, authorizing the Governor to arm an equip a reserve force of one hundred men, for active service. The object, we suppose, to prevent a repetition of the disgraceful scene enacted at New Albany, by the Seymour Vigilance Committee.

HIGHWAY ROBBERY.—The Ft. Wayne Democrat says that a farmer by the name of Lerhman was robbed of the proceeds of a load of pork, some \$90, by a couple of highwaymen, who with presented revolvers, in the Dick Turpin style, demanded his money or his life. Two brothers James and Joseph Smith—not Dandy Jim—have been arrested and held to answer for the crime.

Railroad News.—The Committee appointed by our citizens to solicit private subscriptions to the Cincinnati, Richmond and Fort Wayne railroad had secured some thirty thousand dollars on the 1st of January. If our citizens, who are able, and who would be benefited by the road, would subscribe one half what they ought to, the remaining twenty thousand could be secured without any trouble.

The Jay County Republican says that the people of Jay county are trying to raise fifty thousand dollars. The Republican is urging the people to move in the matter.

The Winchester Journal says that the people of Deerfield are trying to secure sufficient stock to induce the railroad company to make their place a point on the Richmond and Fort Wayne road. The people of Ridgville are also laboring to have their enterprising town made a point on the same.

The Richmond Telegram says that all but thirty thousand dollars of the stock required to prepare the bed of the Richmond and Fort Wayne railroad for the iron, has been subscribed, and that responsible parties have contracted to furnish the iron as fast as the road is ready for it. Of course the small balance of stock will be taken up without delay, and the road is certain to be commenced at an early day.

RECONSTRUCTED.—We notice that some of those who became reconstructed on or about January 1st, will have to "swear off" again, unless like Rip Van Winkle's tipting, "this don't count."

THEOLOGICAL DISCUSSION.—The long talked of discussion between Rev. Hammond, of the Methodist Episcopal Church and Shaffer of the Methodist Protestant Church, commences at Monroeville, Wednesday, January 13th. The resolution for discussion is as follows:

Resolved. That the doctrines of the Methodist Protestant Church are not the doctrines taught by the Bible.

From Washington.

WASHINGTON, Dec. 5.—Congress reassembled to-day, with a full attendance in both houses. No important bills were introduced, and but little legislation was accomplished.

THE SENATE occupied most of the day in discussing a resolution calling on the president for a copy of his late amnesty proclamation, and for the authority for issuing the same. It was claimed by radicals that he had no power to dispense amnesty before conviction. The resolution was finally passed.

A bill to pay a loyal claimant in Georgia for property destroyed by Sherman's army was debated at length without result, but with indications that such a class of claims would not be paid at present.

Senator Edmunds to-day presented the resolutions of the Vermont legislature asking that in view of the large and numerous grants of public lands to western and southern states and railroad corporations, congress shall take into consideration the claim of Vermont to an equitable and just share in the general distribution, and for the purpose of promoting its educational and internal improvement systems.

The investigation of Judge Busted's case before the judiciary committee of the house progresses. The testimony, even thus early, is admitted by Busted's friends to be of a damaging character; and still stronger, it is said, will be forthcoming. The eminent carpet-bagger stands a fair chance for transmitting his name to posterity in an impeachment trial.

Menard, the Louisiana colored man who came in high feather with his congressional aspirations has left with a fallen crest. His impetuous condition was relieved by the freedmen's bureau, which furnished him with transportation free of charge to New Orleans.

The idea prevailing in the west, that there is danger of Congress raising the tax on whisky, is erroneous. It is true that money has been subscribed in New York, Cincinnati, and the other cities, for this purpose; but the movement has fallen still-born. The proposition has not been named in the ways and means committee, and not one member in that committee is in favor of it.

The schools and colleges of the south have been more numerous attended this season than ever before.
