THEY PARTED

Venus Family Have Trouble

Mrs. Carl Venus of Bluffton Deserts Her Home and Little Children.

The Bluffton News tells the following story of the trouble of Mr. and Mrs. Carl Venus who formerly lived in Decatur, Carl having worked in this office for a year or more: A sad case of domestic trouble and the secession of a well known young couple was brought to the attention of the News today. The parties referred to are Mr. and Mrs. Carl Venus. The young wife left her home and the city Sunday evening and so far as could be learned today her folks have not heard from her since. She left three small children, the oldest of whom is four years of age. Mr. Venus left this morning for his work in Anderson and the circumstances connected with the separation were furnished by a member of his family. As nearly as could be learned Carl was home from Anderson where he is employed in a printing office, to spend Sunday with his family. They had as guests for the day Mr. and Mrs. Ibaugh, a Hartford City printer and his wife. The latter left the Venus home in time to catch the 5:45 interurban car and immediately after they left Mrs. Venus informed her husband that she had decided to leave home as she could not live with him any longer. According to his story he insisted on her staying with the children, saying that he would go away and would send his money to her. The wife was determined, however, and left home with her personal effects. Her grandfather, Mr. Jones, who had been staying with her, followed her and saw her board the interurban car at Wiley Avenue. It is supposed she went to Hartford City. Mr. Venus claimed that they did not have a quarrel. Before leaving this morning Mr. Venus placed his three children in his mother's care, also removing part of his goods to his parent's home. Neighbors of the family say that the couple have had domestic troubles before and that they separated once or twice before this. From their stories they seem inclined to blame the husband. Another sad feature of the case is that Mrs. Venus' father is lying sick and at the point of death. She is a daughter of A. L. Minehart, who has lung trouble with no hopes of recovery.

SMALL LOSS

Russians Report Port Arthur Assault

Lake Shore Passenger Train Dashes Into Open Switch With Fatal Results.

ST. PETERSBURG, March, 23—Dispatches to the Czar shown that the Russians sustained no great damage by the recent Japanese bombardment of Port Arthur, having only five soldiers killed and ten wounded. Two hundred shells were thrown into the city. The feeling here is that the Japanese tactics are preliminary to an attempt to cut off Port Arthur and commence the land siege

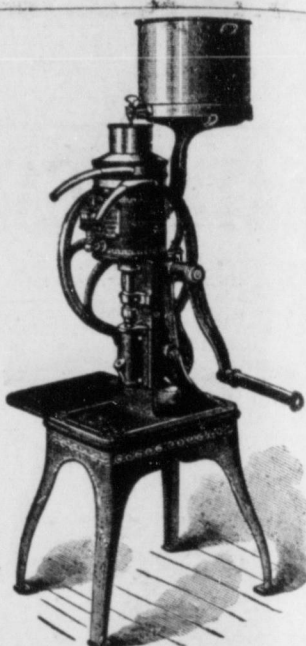
